**H 3518 Joint Resolution, By Owens, Taylor, Daning and others**

A JOINT RESOLUTION TO PROVIDE THAT UNTIL JUNE 30, 2016, THE COMMISSION ON HIGHER EDUCATION AND THE PRESIDENTS OF PUBLIC COLLEGES AND UNIVERSITIES SHALL TAKE CERTAIN ACTIONS TO SUPPORT THE EFFORTS OF THE GENERAL ASSEMBLY TO ESTABLISH ACCOUNTABILITY-BASED FUNDING FOR PUBLIC COLLEGES AND UNIVERSITIES.

**H 3445 General Bill, By Govan, J.E. Smith, Mack, and others**

A BILL TO AMEND SECTION 59-127-20, AS AMENDED, CODE OF LAWS OF SOUTH CAROLINA, 1976, RELATING TO THE BOARD OF TRUSTEES OF SOUTH CAROLINA STATE UNIVERSITY, SO AS TO REVISE THE NUMBER OF BOARD MEMBERS AND THE MANNER IN WHICH THEY ARE ELECTED TO ACCOUNT FOR THE NEW SEVENTH CONGRESSIONAL DISTRICT, THE ELIMINATION OF THREE AT-LARGE SEATS, THE ADDITION OF A SEAT HELD BY AN ALUMNI OF THE UNIVERSITY WHO IS ELECTED BY THE SOUTH CAROLINA STATE NATIONAL ALUMNI ASSOCIATION OR ITS SUCCESSOR, AND TO REVISE OTHER PROVISIONS RELATING TO TERMS OF BOARD MEMBERS.
