Medicare open enrollment (Oct. 15–Dec. 7) is coming soon, so now's the time to learn more about what beneficiaries will receive in the mail. Our updated Guide to Mailings and Key Events in 2014/2015 is based on the Centers for Medicare & Medicaid Services (CMS) 2014-2015 mailings chart and provides detailed descriptions of the content of each mailer, hints to help clients, and a one-page, color-coded chart with links to most notices in English and Spanish. The guide also contains information about several Part D and Medicare Advantage Special Enrollment Periods.

CMS releases guidance on reassignment of LIS beneficiaries

Last week, CMS issued two memos about Part D and Medicare Advantage (MA) plan reassignments for Low Income Subsidy (LIS) beneficiaries. The memos explain how CMS will handle the reassignment of beneficiaries whose plans will no longer have a Part D premium at or below the LIS benchmark, are non-renewing or have a service reduction area, and what notices those beneficiaries can expect to receive in the mail.

SNAP cost-of-living adjustments go into effect next month

The Food and Nutrition Service recently released the fiscal year (FY) 2015 Cost-of-Living Adjustments (COLA) to the Supplemental Nutrition Assistance Program (SNAP) maximum allotments, income eligibility standards, and deductions. Effective Oct. 1, maximum allotments will increase for 48 states, D.C., Guam, and U.S. Virgin Islands. Shelter cap values and minimum standard deductions will also see slight increases.
