2015 Major Flood Report Statewide Operations

(8:00 AM- REPORT)
October 14, 2015

Statewide Summary – More roads are being opened to traffic every day, as the number of closed roads is significantly lower than yesterday, however caution is required if traveling (and especially at night.) **Never ever drive around a barricade.**

SC 12 (Jarvis Klapman Blvd.) opened in Columbia at 1 PM yesterday.

SC 51 crossing at Black River in Georgetown County may open as early as Thursday if underwater inspection results are positive.

SCDOT (construction group) and FHWA damage assessment teams continue to work to expedite repairs. SCDOT is coordinating/ documenting all mitigation activities in accordance to FEMA requirements for reimbursement.

SCDOT debris removal contractors have been activated for removal of construction and demolition debris in the 11 FEMA disaster declared counties and will start work today. (More counties could still be added by FEMA to the declared list.)

If the road is covered with water, “turn around, don’t drown”.
