## **Bobby Harrell Unanimously Reelected Speaker**

### *Leadership Record earns Harrell another term as House Speaker*

(Columbia, SC) – Today, the Members of the SC House of Representatives and our state's 120th General Assembly voted unanimously to elect [Bobby Harrell](#) to another term as their House Speaker. The Election of Officers was one of the first actions taken by the newly-elected House during its two day Organization Session. All of the previous session's Officers sought reelection this year, and as with Speaker Harrell, they too received resounding approval from the Membership to continue on in their leadership positions.

First elected House Speaker in 2005, Harrell's tenure has been one of proven fiscal discipline, responsible government and leadership on conservative Reform. Over the course of his Speakership, the House has successfully delivered on many key issues:

- ☐ \$17 billion in Total Tax Cuts
  - SC has the Lowest Taxes in the Nation per capita
  - Cut Small Business Income Taxes by 40%, Personal Income Taxes Cut, Elimination of Grocery Tax, SC Taxpayer Fairness Act, Homeowners' Property Taxes Cut by Almost Half
- ☐ Limited Government Growth
  - Balanced Budget Every Year
  - Multiple Spending Limit Bills
  - Under Harrell: >1% Average Annual Budget Growth Rate
  - Since 1994: 2.5% Average Annual Budget Growth Rate
  - Increased General Reserve Fund – 3% to 5% years ahead of schedule
