Hi Carenn,

I think one of the items I was supposed to provide is current congregate care stats. You'll need to decide how to send these:

- Among all children in SC foster care on 3/31/2015, 2849/3757=75.8% were placed outside congregate care settings.
- Among children 12 and under in SC foster care on 3/31/2015, 2189/2593=84.4% were placed outside congregate care settings.

They may have asked for 2014 numbers also, but I don't have those readily available.

They didn't request it, but I expect they'll want tables by age ...
