What are the directions for business owners?

If the business has filed a South Carolina tax return since 1998 to the present, you should register with Dun & Bradstreet Credibility Corp who will give South Carolina businesses, a CreditAlert product that will help them stay alerted to changes in their scores or ratings and other indicators of fraudulent activity that could be taking place on their business. Even something as simple as a change to a business address

or a company officer change would set off an alert to the business owner. The cost will be waived for residents of the state.

There are two ways to register:

Option One: Sign up online.

Go to visit www.DandB.com/SC to initiate the registration process.

Option Two: Call Dun & Bradstreet Credibility Corp Call Center.

Call 1-800-279-9881 to complete the process with a live agent.
