Dear Governor Haley:

Below please find a list of U.S. Army Corps of Engineers (Corps) water resources development projects and separable elements located in your state that have been identified for deauthorization pursuant Section 6001(c) of the Water Resources Reform and Development Act of 2014 (WRRDA 2014), Public Law 113-121. Section 6001(c) directs the Corps to identify water resource development projects and separable elements for deauthorization. The Corps has not evaluated the merit of the projects on the list. Per Section 6001(e) of WRRDA 2014, the projects or separable elements on the final list submitted per Section 6001(d) of WRRDA 2014 to Congress will be deauthorized after 180 days, unless Congress passes a joint resolution disapproving the final list or the non-Federal interest for a project or separable element provides sufficient funds to complete the construction of a project or separable element. Section 6001(c) is included below for your reference:

*(c) INTERIM DEAUTHORIZATION LIST.—*

*(1) IN GENERAL.—The Secretary shall develop an interim deauthorization list that identifies each water resources development project, or separable element of a project, authorized for construction before November 8, 2007, for which—(A) construction was not initiated before the date of enactment of this Act; or (B) construction was initiated before the date of enactment of this Act, but for which no funds, Federal or non-Federal, were obligated for construction of the project or separable element of the project during the current fiscal year or any of the 6 preceding fiscal years.*

*(2) SPECIAL RULE FOR PROJECTS RECEIVING FUNDS FOR POST-AUTHORIZATION STUDY.—A project or separable element of a project may not be identified on the interim deauthorization list, or the final deauthorization list developed under subsection (d), if the project or separable element received funding for a post-authorization study during the current fiscal year or any of the 6 preceding fiscal years.*

*(3) PUBLIC COMMENT AND CONSULTATION.—(A) IN GENERAL.—The Secretary shall solicit comments from the public and the Governors of each applicable State on the interim deauthorization list developed under paragraph (1).*

*(B) COMMENT PERIOD.—The public comment period shall be 90 days.*

*(4) SUBMISSION TO CONGRESS; PUBLICATION.—Not later than 90 days after the date of submission of the list required by section 1001(b)(4)(A) of the Water Resources Development Act of 1986 (as added by subsection (b)), the Secretary shall—(A) submit the interim deauthorization list to the Committee on Environment and Public Works of the Senate and the Committee on Transportation and*

*Infrastructure of the House of Representatives; and (B) publish the interim deauthorization list in the Federal Register.*

The amount shown in the column titled "Federal Balance" is a working estimate of the Federal portion of the remaining funds required to complete a project or separable element, and does not include the non-Federal portion. If a non-Federal interest is interested in providing sufficient funds to complete a project or separable element, please contact the appropriate Corps District Commander to discuss the process necessary to develop the total cost to complete the project or separable element.
