Dear Mr. Keck:

We have completed our review of the CMS 372 annual report for the Home and Community-Based Services (HCBS) Waiver listed below. Based on our analysis of the expenditure and recipient data submitted in this report, we find the data acceptable, subject to any future data validation reviews. A comparison of the actual data reported to the most recent CMS approved estimates indicates that the estimated costs without the waivers were not exceeded.

We noted that the total number of users for two services (companion and specialized medical equipment and supplies) slightly exceeded the unduplicated estimates of users in the approved waiver. Please monitor this trend closely. If the trend continues, the state may wish to consider amending the waiver to more closely align future estimates with the actual number of users.
