The discussion centered around the fact that once a county meets their goals, they will have to maintain and then eventually have to "re-certify". ACT is still working out how the details.

So, the discussion that the SC Leadership Team had was that maybe we shouldn't have the 2-year period on the highway signs but rather just the year they were certified, i.e. 2013. Luckily, we haven't begun making the signs or even finalizing the details with Corrections.
