This varies from 10535 in the following particulars:

For Ken Moffit, we added the PEBA board to the indemnity provision in the remainder of the bill (It was omitted in the 2/7/12 version

The employer employee benefit schedule has been included in 9-4-30. My suggestion is to provide only a two year phase in on SCPORS since those rates achieve the differential after the second year. I checked and no Class one member remains active in SCRS and only 1 such member in SCPORS and he earned less than 140 dollars in 2011. I have offered to pay his additional contributions at that level.

I have added the PEBA executor director ex officio to RSIC without a vote and no salary.

I have added an outside audit for RSIC by a firm hired by the State Auditor modeled on the PEBA audit provision.

I have the gov naming the first PEBA board chairman through December 31, 2013.

I have added a requirement for the PEBA board to name an health insurance advisory committee to review and make suggestions on changes in the health plan.

The advisory committee would be established by resolution of the board, which would determine membership, terms, operations, etc. Committee members would get mileage, subsistence , and per diem as provided by law.
