**Patch:** Nikki Haley Pushes Regulatory and Tax Reform in Cabinet Session

Says loosening regulations will help continue growth; creates task force.

Since taking office, Gov. Nikki Haley has made it abundantly clear that her first priority is creating jobs to lift the South Carolina economy. **Thousands more people are working now than when Haley took over in 2011**, but in her State of the State address last month she said that more could be done to free up growth and hiring, particularly among small businesses.

**Note:** Haley's cabinet will issue a report to the Task Force by May 1 that provides information on regulatory burdens and what can be done to repeal or amend them. A 2010 report from the NYU School of Law gave South Carolina a letter grade of "D" for its regulatory review process. "I won't be happy until that's an "A," Haley said

Gov. Nikki Haley has ordered state agencies to conduct a comprehensive review of their procedures and regulations, calling on departments to help create a more business-friendly government. "At a time when you see me focused on jobs, jobs, jobs, this where your agencies come into play in terms of us doing that," Haley told her Cabinet agency directors Tuesday.

**Note:** The agencies' mission, Haley said, is to assess the impact of the regulations to determine whether their costs to businesses and employers outweigh their intended benefits. The reviews will then be evaluated by a new panel appointed by Haley and legislative leaders, with representation from business groups and a conservation group. Agencies ripe for review are the Department of Health and Environmental Control, Department of Labor, Licensing and Regulation and Department of Health and Human Services, Haley said.

Gov. Nikki Haley directed her Cabinet agencies Tuesday to review their regulations, saying South Carolina needs to get rid of government rules that hamper businesses. Haley signed an executive order that creates an 11-member task force to review regulations and make recommendations on which ones to throw out or alter. It also requires her 16 Cabinet agencies to report their suggestions to the task force by mid-May.

**Note:** The Republican governor can't mandate other state agencies do the same, but she's encouraging them to. "We are continuing to make sure every agency in South Carolina is customer-service friendly," she told reporters after her Cabinet meeting. "These agencies work for the taxpayer, for the businesses. If they're costing them time, they're costing them money."

The South Carolina Manufacturers Alliance's (SCMA) President and CEO, Lewis F. Gossett, issued this statement following Governor Nikki Haley's announcement of the creation of a regulatory review task force: "Governor Haley's announcement today of the creation of a regulatory review task force is welcome news. Governor Nikki Haley today signed an executive order establishing the Governor's Regulatory Review Task Force, an eleven member group that will include the chairman of the Small Business Regulatory Review Committee, to review and reduce government involvement in business and create a more simplified and market-friendly regulatory system.

**Note:** According to the governor's order, the task force will develop a report by November 15, 2013, that evaluates South Carolina's current regulatory burdens on all sizes and types of businesses in South Carolina and proposes recommendations to relieve those burdens.

Gov. Nikki Haley is praising House Republicans in South Carolina for proposing to further cut income taxes. Measures introduced in the House differ from her recommendation, but Haley said Tuesday she supports anything that reduces income taxes. Haley wants to eventually eliminate corporate and personal income taxes, as a business recruitment tool.

**Note:** Haley's executive budget recommends eliminating the 6 percent tax bracket, cutting \$26 million. Legislation introduced in the House last month would collapse four middle tax brackets. State economic advisers predict that would reduce revenues by \$80 million.

Most S.C. taxpayers would save an average of \$86 a year under a bill proposed in the S.C. House. Right now, any money that S.C. residents earn up to \$14,500 a year in taxable income is taxed at a variety of rates, anywhere from 3 percent to 6 percent. State Rep. Tommy Stringer, R-Greer, says that is too complicated. He wants to combine all of those tax brackets into a single 3.75 percent tax on taxable income between \$2,850 and \$14,500. Taxable income is how much money you earn in a year, minus any tax deductions or credits you qualify for, such as for dependents or mortgage interest.

**Note:** "Anything that reduces income taxes in this state, I will be for," Haley said. "I am for eliminating (the) income tax. So the fact that the House is even moving on income tax, I applaud them."

Now that Barack Obama has been sworn in for a second term, the focus will again turn to Obamacare and health care exchanges. Campaign donations historically have been a source of corruption and abuses. Operation Lost Trust in 1990 convicted 17 legislators, almost all of them for accepting bribes disguised as campaign contributions. The 1991 Ethics Act struggled with limited success to stop corruption. Recent ethics reform hearings have clearly shown that the law's limits on the size of campaign contributions can be evaded by single donors using multiple political action committees and shell corporations. This must be banned.
