Governor Nikki Haley News:

The State: Haley names new licensing and regulation director

Gov. Nikki Haley appointed an agency lieutenant Monday to head the state department that oversees professional licensing and workplace and fire safety. Richele Taylor has succeeded Holly Pisarik as director of the S.C. Department of Labor, Licensing and Regulation. Taylor was named LLR's deputy director of administration this year after a 14-year legal career, most recently with Fisher & Phillips.

Note: Haley said Templeton and Pisarik have reformed an agency that she called "an absolute mess." The governor, who has made cutting red tape a priority, said Pisarik cut fees and investigation times to make it more customer-friendly during her tenure.

Note: Pisarik is not going far, Haley said, but she declined to provide details: "She will be in our circle."

Gov. Nikki Haley says South Carolina's labor and business licensing agency has a new director, though it's unclear why the current director is leaving. Haley announced Monday that Richele Taylor is her choice to lead the Department of Labor, Licensing and Regulation. The Senate still must confirm her appointment.

The State: New \$12 million bailout for SC State moves forward

State budget leaders agreed Monday on where to get \$12 million to help bailout S.C. State University over the objections of Gov. Nikki Haley. And the money, thought to be another loan for the cash-strapped school, could become a grant in a move that South Carolina's top government accountant said would circumvent usual reviews before spending state money.

Note: Haley said the audit was ordered this spring after state budget leaders agreed to a \$5.5 million loan. "It's completely irresponsible for us to do this at this time," she said, "This is not a Band-Aid where we say, 'OK, you're fine.'"

Note: Haley abstained in the vote Monday to get the money for S.C. State from a \$31 million fund of leftover cash from the previous budget year.

The \$6 million approved last week as bailout funds for South Carolina State University by the S.C. Joint Bond Review Committee will be coming from the Contingency Reserve Fund. The Budget and Control Board on Monday approved the source of the funding by a vote of 3-1, but those voting in favor of it expressed concern about the action they were taking.

Note: Sen. Hugh Leatherman, State Treasurer Curtis Loftis Jr. and Rep. Brian White voted in favor of the motion. State Comptroller General Richard Eckstrom voted against it and Gov. Nikki Haley abstained.

Note: Haley noted she's supportive of the university but could not vote for approving the source of money. She said she was nervous at the last BCB meeting because S.C. State's financial reports differ from those of the budget board. "We have a responsibility to the stakeholders in South Carolina," she said. "We don't know how we're going to fix this. We don't know how big this story is."

The state's financial oversight board agreed Monday to dip into reserves and give South Carolina State University \$12 million over three years, though questions remain about how the money will be doled out and whether the school must repay any of it.

Note: The Budget and Control Board voted 3-1 to get the money from tax collections that came in above advisers' expectations. Gov. Nikki Haley, the board's chairwoman, did not vote, calling the decision completely irresponsible to both the university and taxpayers. "If y'all choose to do this, I will not be any part of it," she said. "There are a whole lot of questions and very few answers."

State Corrections Director Bryan Stirling will stay on in Gov. Nikki Haley's second term, he said Monday. Stirling succeeded William Byars, a former family court judge and director of the state Department of Juvenile Justice who retired. After he was first appointed by Haley in September 2013, Stirling said his top priorities were guard safety and "life lessons" for inmates to help them find jobs once they leave.

The South Carolina Transportation Commission has given final approval to a plan projecting the state will need to spend another \$60 billion during the next quarter century on roads, money which the state does not have. The Statewide Multimodal Transportation Plan, which was the topic of public hearings around the state earlier this year, was approved at last week's commission meeting in Columbia.

Note: Gov. Nikki Haley plans to release her plan for paying for roads next month. But her office has said any road plan will not include raising taxes.
