Subject: MOU for SLED Reimbursement

Good Afternoon Chief Keel and Director Hamm,

Chief Keel provided the Lieutenant Governor with a copy of an MOU that was in place between the South Carolina Law Enforcement Division, the State Ethics Commission, and Governor Nikki Haley's Office regarding SLED Reimbursement for their expenses when they are required to provide protection but the Governor was attending a campaign related event. Lieutenant Governor Bryant is interested in putting a similar agreement in place.

I have taken the agreement that Chief Keel provided and used it as a template for a similar agreement with the Lt. Governor. The main difference is that nature and extent of SLED's duty to protect the Lieutenant Governor, which I'm hoping Chief Keel can help with how I have drafted that component to ensure I have properly captured the nature of their protection. Outside of that I haven't changed any of the definitions.

The draft I am attaching does include two notes, one about the changes I made to the Preamble and one about a need to work on the locations in the travel reimbursement section since the Lt. Governor does not live in Columbia.

I am hoping that you can both provide feedback on this document and that we can work together to implement the agreement.
