Violations of the Rights herein expressed shall automatically Execute a Writ of Mandamus On and For the Record Pursuant to TREATY LAW, being the Supreme LAW of the Land, The Treaty of Peace and Friendship-(1787)-(1836) Article 20- Article 21 Hague Convention on Private International Law

Pursuant to THE UNITED STATES CONSTITUTION Article III-Section two (2) Trial by Jury, Original Jurisdiction Article VI-Debts, Supremacy, Oaths Amendment V-(5) Trial & Punishment Amendment IX-(9) Un-enumerated Rights Amendment X-(10)
