Stat of the Week - \$3 Billion: South Carolina exports threatened by an emerging trade war.

Tariffs and Trade Wars

With South Carolina having a strong export economy, it's no surprise that we stand to lose quite a bit from an emerging trade war with China Canada, Mexico, and the European Union. The U.S. Chamber estimates these tariffs will have a \$3 billion economic impact on our state, the 8th highest in the U.S. Per capita, South Carolina has the 5th highest impact in the U.S. Below you'll see the top ten states with the highest economic impact from these tariffs, and the top ten states' per capita impact.

[resolution 88-11](#) that would give Congress a role in approving tariffs that could threaten national security, like the steel and aluminum tariffs that are already in effect, and proposed tariffs on automobiles. Senators Lindsey Graham and Tim Scott voted against the resolution.

BMW said this week that [it will raise prices on automobiles](#) made in South Carolina and plans to move some production overseas due to the tariffs. We are in routine contact with federal officials about the impact we believe these tariffs will have on the Upstate economy and jobs, and we are continuing to watch the unfolding situation very closely.

Governor Vetoes Business Tax Credits

A couple weeks ago we told you about a bill, [S.1043](#), chock-full of business-friendly tax incentives that will help our state compete economically. The bill reauthorizes the abandoned buildings tax credit, expands job development credits for more business to qualify, gives a credit for using Certified SC Grown products, among others. Separately, these bills were top priorities for the Upstate business community, but put together, they quickly became a must-pass.

However, this bill was subsequently [vetoed by Governor McMaster](#). From our conversations with legislators, we have a good feeling that they will override the Governor's veto when they return to Columbia for a special session in September. Stay tuned. We will need your assistance in overcoming yet another veto of a business priority.
