

INVITATION FOR BIDS

The Housing Authority of the City of Columbia, S.C. will receive bids for furnishing all materials and labor for (A) installing blown insulation in the attics of 30 buildings at S.C. 2-1, Gonzales Gardens. (B) installing blown insulation in the attics of 26 buildings at S.C. 2-2 Allen-Benedict Court, and/or (C) for installing blown insulation in 56 buildings, 30 buildings at S.C. 2-1, Gonzales Gardens, and 26 buildings at S.C. 2-2 Allen-Benedict Court. A, B, and C includes the Administration Building(s) at the specified project(s). It shall not be necessary to bid on all of the above. Bids on the above will be received until 2:00 P.M. E.S.T. on March 27, 1979, at the Central Office of the Housing Authority of the City of Columbia, S.C., 1505 Garden Plaza (across Forest Drive from Providence Hospital) at which time and place all bids will be publicly opened and read aloud.

Proposal forms of contract documents are on file at the office of The Housing Authority City of Columbia, S.C. 1505 Garden Plaza (P.O. Box 4307), Columbia, South Carolina 29240, and at the Plan Rooms of the Associated General Contractors of America, Columbia, South Carolina and F. W. Dodge in Columbia, South Carolina.

Copies of the documents may be obtained by depositing \$10.00 with The Housing Authority City of Columbia, South Carolina, P.O. Box 4307, Columbia, South Carolina 29240, for each set of documents so obtained. The deposit will be refunded to each person who returns the plans, specifications and other documents complete and in good condition within 10 days after bid opening. Plans for this project may be reviewed at our Plan Room located in the Modernization Department at Saxon Homes.

A certified check or bank draft, payable to The Housing Authority City of Columbia, South Carolina, or a satisfactory bid bond executed by the bidder and acceptable sureties in the amount equal to five percent of the bid shall be submitted with each bid. All contractors must present documented proof of being licensed in the State in which the project is to be contracted if the bid amount exceeds \$30,000.

The successful bidder will be required to furnish and pay for satisfactory performance and payment bond.

Attention is called to the provisions for equal employment opportunity, and payment of not less than the minimum salaries and wages as set forth in the Specifications must be paid on this project.

The Housing Authority City of Columbia, South Carolina reserves the right to accept or reject all or any part of the above bids or to waive any informalities in the bidding.

No bid shall be withdrawn for a period of 30 days subsequent to the opening of bids without the consent of The Housing Authority City of Columbia, South Carolina.
