It is not the duty of the governors office to populate these boards, rather to perform the ministerial function of appointment upon recommendation of local delegation.

The problem is there are numerous expired terms and numerous people serving in unexpired terms. Union, Allendale, Lancaster and Sumter counties.

The thought is : the governor's office can jump start the process by requesting each delegation select names for each unexpired term and submit them by September 15.

If possible, I would like to meet with you and the boards and commission staffer to discuss.
