Dear Mr. and Mrs. Baker,

Thank you for contacting my office regarding your concerns about the ongoing illegal immigration crisis at our nation's southern border. As the daughter of immigrants who came to this country legally, I assure you that I value the American tradition of being a nation of immigrants, but first and foremost, I understand that we are a nation of laws. As long as our border remains dangerously unsecure and incentives for mass migration continue to exist, I will continue to call for the federal government to change its policies and uphold the rule of law.

In July, I spoke directly with Secretary Jeh Johnson of the United States Department of Homeland Security about the influx of unaccompanied minors and the impact it may have upon the State of South Carolina. I was assured that South Carolina facilities are not being used as mass shelters to house the unaccompanied minors crossing our border – and I asked to be personally notified of any shift in that policy. Recently, we learned that approximately 434 unaccompanied minors have been placed with sponsors in our state, but the federal government will not provide names, ages, locations, or sponsors citing federal privacy issues.

The humanitarian crisis of unaccompanied minors at our border, once again, highlights the failure of the federal government to adequately perform its most basic and crucial function: securing the sovereignty of the United States of America. Be assured that I will continue to monitor this situation and will take action when and where possible to deter illegal immigration.
