The affiant states that there is probable cause to believe that the defendant named above did commit the crime(s) set forth, and that such probable cause is based on the following facts:

That on November 30, 2016, while at 6146 Hwy 165, Ravenel, in the County and State aforesaid, the above named defendant, **Randall Hobart Robertson**, did commit the offense of violation section 16-15-405 of the South Carolina Code of Laws, 1976 as amended, **Second Degree Sexual Exploitation Of A Minor**, in that he did willfully, unlawfully, and knowingly receive, create digital electronic files of, and redistribute, material that contains a visual representation of a minor engaged in sexual activity or appearing in a state of sexually explicit nudity as defined by SC statute 16-15-375. The defendant knew the character or content of the material.


On November 29th, 2016 Investigator Sturgill, a member of the South Carolina ICAC task force, was conducting an investigation into the sharing of child pornography on a peer-to-peer (P2P) file sharing network. Inv. Sturgill identified a user on the network, with the Internet Protocol (IP) address 69.242.194.180, which had made available for download to other users the network files that contained terms known to Inv. Sturgill, through his training and experience, to be related to child pornography. Between 11/29/2016, and 11/30/2016, Investigator Sturgill completed single source downloads of several files of interest from the user at IP 69.242.194.180. Inv. Sturgill confirmed several of these files to be a violation of the SC law of Sexual Exploitation of a minor. Inv. Sturgill determined the user from whom he had downloaded the files was located at 6146 Hwy 165, Ravenel, SC. Inv. Sturgill referred the investigation through the SC ICAC task force to Detective Bowen. Detective Bowen reviewed the files and confirmed several of them to contain visual depictions of the sexual exploitation of minors. One such file titled, "6살 유치원생 제대로 삽입 사정 장면", depicts an erect adult penis being inserted into the vagina of an obviously pre-pubescent child that appears to be 4-6 years old. On January 26, 2017, Det. Bowen served a search warrant on the residence. The defendant was present at the time of the search warrant. During an interview the defendant confessed to using the file sharing network to download material he knew to contain a visual representation of a minor engaged in sexual activity or appearing in a state of sexually explicit nudity. The defendant confessed to using search terms known to him to be related to child pornography. The defendant confessed to seeking out child pornography of children he believed to be approximately 12 years old. The defendant also confessed to knowing that he was distributing the files that he sought out and downloaded.

This information is known through the investigation of Detective J. Bowen of the Charleston County Sheriff's Office, and of the South Carolina ICAC task force, and he is witness to prove the same against the form of the statute in such case made and provided against the peace and dignity of the State.
