- The Lowcountry Senior Center (the one you will be visiting) and Waring Senior Center (currently under construction) are owned by the City of Charleston and managed by Roper St. Francis Hospital.
- Membership rates for the center range from \$70-105 annually for in-county members; some classes / programming have additional fees.
- The Lowcountry Senior Center features a walking trail, outdoor fitness stations, a fitness center, computer lab, and flexible space for classes and programming.

Let's do the one on James Island so that he can see that operation. Will you please set it up and send me the details. He just needs to be on Kiawah at 1:30. Thanks


