Dear Governor, Haley:

I Am Humbly Writing Your Office In Regards To A Potential Issue Of Fraud Within The Correctional Education Division Of S.C.D.C. And The Palmetto Unified School District.

Currently I Am Housed At The Wateree River C.I. (STATE FARM), I Am A Participant In The C.E.O. Program Which Teaches (N.C.C.E.R.) National Center For Construction Education And Research Curriculum. I Have Completed The 10 hour Safety, Core Curriculum, Heavy Equipment - I And Recently Welding - I, But There Seems To Be A Dilemma.

It Has Been Brought To My Attention That The Correctional Education Division Of S.C.D.C. And The Palmetto Unified School District Will Not Furnish The \$15 A Course Registration Fee To Ensure That My Skills Are Validated.

At This Present Time The Palmetto Unified School District has Issued Me A Certificate for Satisfactorily Completing The Previously Listed TRADES AND CURRICULUM, but on The BACK OF EACH CERTIFICATE THERE IS A REFERRAL TO VERIFY MY ACCOMPLISHMENTS AT THE N.C.C.E.R. NATIONAL CRAFT TRAINING REGISTRY, PO BOX 141104 GAINESVILLE, FL, 32614, (352)334-0911, WWW.NCCER.ORG.

Governor, Haley, with Full Respect This IS An ACT OF FRAUD AND COPYRIGHT INFRINGEMENT. The N.C.C.E.R. Registry Provides Its OWN Transcripts Along With A TRADE MEMBER CARD AND NUMBER, AND WITH THE PALMETTO UNIFIED SCHOOL DISTRICT PLACING THE N.C.C.E.R. CREDENTIALS ON THE BACK OF MY CERTIFICATES, THERE RAISES ISSUES OF PLAGIARISM ALONG WITH VIOLATIONS OF LAW.

This IS A VERY IMPORANT ISSUE for me DUE TO The length of time I have served. I'm "15" months AWAY from Finishing A 15 Year 85% Sentence AND During my time I have Reinvented Myself with what little is offered for a violent offender. All I have to show is 13 years of Prison Work History AND To have my Accomplishments INVALIDATED undermines my chances of "GETTING OUT, STAYING OUT AND SUCCEEDING"!

MY PRAYERS GO OUT TO EVERYONE AFFECTED BY THE STATES (ECONOMICALLY) FROM THE FLOOD, WHITECLAW RIVER C.I. WAS ALSO AFFECTED, AND MY SKILLS WERE PUT TO USE BY PREPARING THE 1-TON SAND BAGS FOR THE NATIONAL GUARD. I AM GOING TO PURSUE A CAREER IN HEAVY EQUIPMENT OPERATING AND MY SKILLS ARE IN NEED WITHIN THE STATES WORKFORCE, BUT IF MY CREDENTIALS DON'T CHECK OUT, THIS CAN DAMAGE ANY OPPORTUNITY I MAY HAVE. IT'S NOT GOING TO BE EASY FOR ME AFTER SERVING 15 YEARS IN PRISON AND I NEED ANY AND EVERY OPPORTUNITY I CAN RECEIVE FROM THE STATE AND YOUR OFFICE (SPECIALLY IN REGARDS TO THE MATTER AT HAND).

CURRENTLY I AM INDIGENT AND HAVE NO WAY OF EARNING A INCOME TO PAY FOR MY OWN N.C.C.E.R. REGISTRATION, AND THIS IF N.C.C.E.R. WILL EVEN ACCEPT A PAYMENT FROM A INMATE DUE TO THE PROGRAM BEING STATE AND FEDERALLY FUNDED. I HUMBLY ASK THAT YOU AND YOUR OFFICE INVESTIGATE THIS SITUATION. I HAVE ALSO WRITTEN TO DIRECTOR STIRLING ON THESE SAME ISSUES ALONG WITH NOTIFYING MY MAIL ROOM DIRECTOR ON ME MAILING THESE LETTERS AND SENDING NOTIFICATION TO MY GRIEVANCE COORDINATOR.

Governor, Haley I'm stuck in the middle and will suffer the most harm, Please correspond with me on these matters and I pray to hear from your office soon. Your authority is needed due to the issues of law and injury.
