

Dear Sir or Madam:

This firm represents Nestle USA, Inc., in a lawsuit pending in South Carolina. The mother, Brandy Austin, of an infant, Christa Austin, has filed a lawsuit against Nestle USA, Inc., in which she alleges that Christa Austin was exposed to the bacteria *Enterobacter sakazakki* ("E-sak") through ingestion of powdered infant formula manufactured by Nestle. Nestle denies all such allegations.

An investigation was conducted by the Food and Drug Administration (FDA) in or about September - October 2006. Upon information and belief, representatives of the South Carolina Department of Health and Human Services ("SC DHHS") may also have been involved in this inquiry, or may independently have records concerning Brandy Austin or Christa Austin. During the investigation, a number of samples are believed to have been taken by the FDA investigator and/or the SC DHHS or CDC representatives, which may have included infant formula samples and environmental samples from the infant's home. Nestle has been advised that the formula samples tested by the FDA were negative for the E-sak bacteria.

All agency records concerning this event, including, but not limited to, any formula and environmental samples taken, and the test results of those samples, are highly relevant evidence to the lawsuit described above.

All agency records concerning Brandy or Christa Austin and/or this event, including, but not limited to, any formula and environmental samples taken, and the test results of those samples, are highly relevant evidence to the lawsuit described above.

Pursuant to the Freedom of Information Act, South Carolina Code of Laws § 30-4-10, and any implementing regulations, I hereby request that the complete SC DHHS file(s) relating to this event and/or investigation be produced to us at this time, including, but not limited to:

- 1) Any and all test results for samples of infant formula, water sources, and other environmental specimens collected in connection with infant Christa Austin's reported alleged exposure to E-sak;
- 2) Any and all protocols utilized by the SC DHHS in collecting and testing the previously referenced samples;
- 3) Reports, memoranda, notes and all such documents generated by any SC DHHS investigator or representative;
- 4) Any and all attachments and/or exhibits referenced in the SC DHHS investigator's or representative's reports, memoranda, and notes;
- 5) Items collected during the investigation, whether or not listed as attachments to the aforementioned documents, including, but not limited to: photographs, interviews, statements, informational listings, etc.;
- 6) All correspondence related to the events described herein, including, but not limited to, all correspondence between the SC DHHS and any other government agencies, correspondence between the SC DHHS and any of the infant's medical providers, and correspondence between the SC DHHS and the infant's parents or caregivers; and
- 7) All documents related to Brandy Austin or Christa Austin's application, enrollment, participation in, and/or receipt of assistance or benefits from the Women, Infants and Children ("WIC") Program.

We will pay all reasonable processing and photocopying fees associated with this request. If you regard any of the requested documents as potentially exempt from disclosure requirements, I request that you nonetheless exercise your discretion to disclose them. Please release all reasonably acceptable non-exempt portions of documents. To permit me to reach an intelligent and informed decision whether or not to file an administrative appeal of any denied material, please describe any withheld records (or portions thereof) and explain the specific basis for your exemption claims. Please also notify me of appeal procedures available under law.

I enclose herewith an authorization executed by Brandy Austin, the mother of the minor child, authorizing us to obtain full, complete, unredacted copies of all records in your agency's possession, custody, or control related to the above-referenced incident.

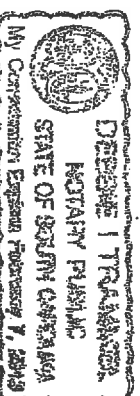
