Update: The shooting happened in the parking lot of the Waffle House.

(Charleston County, SC) On July 31, 2016, shortly before 6:00 a.m., Charleston County Sheriff's Office deputies were dispatched to 3565 Savannah Highway, Waffle House, to investigate a reported shooting. Upon our deputies' arrival on scene, it was reported that two black males were involved in a verbal disputes escalating into physical altercation. During this altercation, one of the males were shot. The suspect fled the scene in an unknown type of vehicle. The victim was transported to Medical University of South Carolina to be treated for his injuries. The last update on the victim's status indicated that he was still recovering from his injuries.
