

The regular monthly meeting of the Highways and Public Transportation Commission was held at the offices of the State Highways and Public Transportation Department in Columbia, South Carolina, at one o'clock p.m. on February 18, 1993. In compliance with the "Freedom of Information Act", the news media was advised in writing of the time, date and place of this meeting.

SECTION 1: The Commission meeting convened in the Auditorium of the Headquarters Building for the purpose of recognizing the Department employees who traveled to Florida to assist during the Hurricane Andrew crisis. Secretary of Transportation Ben Watts and Stan Cann of the Florida Department of Transportation presented certificates and thanked each one for their aid.

SECTION 2: On motion of Commissioner Harvey, seconded by Commissioner McWhirter, the Commission unanimously passed a motion adopting as the position of the Commission a statement presented by Executive Director Fanning on various concerns affecting the Department, as shown in the Appendix.

SECTION 3: The Minutes for the meeting of January 21, 1993, copies of which had been previously mailed to each member of the Commission were approved.

SECTION 4: The Commission unanimously passed a motion approving monthly reports as published by the Department of activities for the month of January, 1993.

SECTION 5: The Commission unanimously passed a motion approving purchase orders issued for amounts in excess of \$10,000.00, during the month of January, 1993, as shown in the Appendix.

SECTION 6: The Commission unanimously passed a motion authorizing the Department to enter into an agreement with the University of South Carolina for photologging/videologging at an estimated cost of \$50,000.00, as shown in the Appendix.

SECTION 7: The Commission unanimously passed a motion authorizing the Department to enter into Supplemental Agreement No. 4 with Post, Buckley, Schuh & Jernigan, Inc., for additional services related to the Laurens Bypass at an estimated cost of \$110,395.86, as shown in the Appendix.

SECTION 8: The Commission unanimously passed a motion authorizing the Department to increase the existing "on-call" contract with Ralph Whitehead and Associates by an additional \$350,000.00, as shown in the Appendix.

SECTION 9: The Commission unanimously passed a motion authorizing the Department to enter into Supplemental Agreement No. 15 with Parsons, Brinckerhoff, Quade & Douglas, Inc., for additional engineering services related to the US 501 improvement project between Conway and Myrtle Beach at an estimated cost of \$1,500,000.00, as shown in the Appendix.

SECTION 10: The Commission unanimously passed a motion authorizing the Department to enter into Supplemental Agreement No. 11 with Sverdrup Corporation for right of way acquisition services for Segment No. 1, US 17 to SC 90, of the proposed Conway Bypass in Horry County at an estimated cost of \$100,000.00, as shown in the Appendix.

SECTION 11: The Commission unanimously passed a motion authorizing the Department to select "on-call" basis firms for preconstruction field surveying and for the development of highway and/or bridge projects at an estimated cost of \$350,000.00, as shown in the Appendix.

SECTION 12: The Commission unanimously passed a motion authorizing the Department to enter into an agreement with the City of North Myrtle Beach for the purpose of hiring a consulting engineering firm to examine methods to improve traffic flow and traffic safety on US 17 at an estimated cost of \$50,000.00, as shown in the Appendix.

SECTION 13: The Commission unanimously passed a motion authorizing the Department to select an on-call consultant for archaeological investigations for statewide projects at an estimated cost of \$350,000.00, as shown in the Appendix.

SECTION 14: The Commission unanimously passed a motion authorizing the Department to enter into agreement with the City of Cayce for the transfer of a historic metal truss bridge to be used as a pedestrian bridge by the city in the development of a public park on the west bank on the proposed Congaree Park, as shown in the Appendix.

SECTION 15: The Commission unanimously passed a motion accepting a report by the Department concerning the execution of a gratis quitclaim deed dated October 30, 1992 conveying approximately 0.02 acre of land in Saluda County to Herman C. Shealy, as shown in the Appendix.

SECTION 16: The Commission unanimously passed a motion accepting a report by the Department concerning the execution of a gratis quitclaim deed dated November 17, 1992 conveying approximately 0.07 acre of land in Greenwood County to Greenwood Petroleum Company, Inc., as shown in the Appendix.

SECTION 17: The Commission unanimously passed a motion accepting a report by the Department concerning the execution of a gratis quitclaim deed dated December 15, 1992 conveying approximately 0.31 acre of land in Greenwood County to Greenwood Petroleum Company, Inc., as shown in the Appendix.

SECTION 18: The Commission unanimously passed a motion accepting a report by the Department concerning the execution of a gratis quitclaim deed dated January 8, 1993 conveying approximately 0.6 acre of land in Lancaster County to D.A.V. Chapter No. 14 and V.F.M. Post 5936, as shown in the Appendix.

SECTION 19: The Commission unanimously passed a motion accepting a report by the Department concerning the execution of a gratis quitclaim deed dated January 8, 1993 conveying approximately 1,125 SF parcel of land in Orangeburg County to Mt. Sinai Holiness Church of God, Inc., as shown in the Appendix.

SECTION 20: The Commission unanimously passed a motion accepting a report by the Department concerning the execution of a quitclaim deed dated January 18, 1993 conveying approximately 0.402 acre of land in Lancaster County to Frankie McManus for the consideration of \$350.00, as shown in the Appendix.

SECTION 21: The Commission unanimously passed a motion accepting the sale by the Department of surplus right of way property on 18 Hillcrest Drive, Greenville, South Carolina, as shown in detail in the Appendix.

SECTION 23: The Commission unanimously passed a motion amending the June 18, 1992 allocation of State Transportation Assistance Program State General Funds for Public Transportation for FY 92-93, as shown in detail in the Appendix.

SECTION 24: The Commission unanimously passed a motion authorizing budget increases for FY 92-93 as approved by the Joint Appropriation Review Committee and Budget & Control Board, as shown in detail in the Appendix.

SECTION 25: The Commission unanimously passed a motion authorizing the allocations of transfers and closures of accounts of State Highway funds for capital improvements/land and buildings, as shown in the Appendix.

SECTION 26: The Commission unanimously passed a motion authorizing the award of a building contract to Contract Construction, Inc., for the low bid of \$837,000.00, plus \$8.00/L.F. for Well Drilling, as shown in the Appendix.

SECTION 27: The Commission unanimously passed a motion approving the sale of surplus used motor vehicles and equipment located at the Department's Equipment Depot, Shop Road, Columbia, South Carolina, bids for which were received on January 20, 1993, as shown in the Appendix.

PUBLIC CONFIDENCE IS OUR MOST IMPORTANT ASSET -- MORE IMPORTANT THAN OUR HEAVY EQUIPMENT, TECHNOLOGY OR EVEN OUR ENGINEERING SKILLS. AND PUBLIC CONFIDENCE IS AN ASSET THAT WE MUST WORK TOGETHER TO RESTORE.

MANY THINGS OF WHICH WE CAN FEEL PROUD. SOUTH CAROLINA HAS ONE OF THE BEST TRANSPORTATION SYSTEMS IN THE COUNTRY.

AND THAT'S NOT JUST BOASTING. IT'S BEEN CRITICAL TO OUR ABILITY TO MEET THE TRANSPORTATION NEEDS OF INDUSTRY AND GIVE SOUTH CAROLINA THE COMPETITIVE EDGE WE SO DESPERATELY NEED. A CASE IN POINT IS THE DECISION OF BMW TO LOCATE ITS FIRST NORTH AMERICAN MANUFACTURING FACILITY IN SOUTH CAROLINA. JOHN WARREN, CHAIRMAN OF THE STATE DEVELOPMENT BOARD, HAS SAID THAT NEGOTIATIONS HINGED ON WHICH STATE'S INFRASTRUCTURE WOULD BEST MEET THEIR NEEDS. BMW NAMED OUR ABILITY TO MEET THEIR LOGISTICAL NEEDS THROUGH THE AIRPORT, THE PORT AND THE CONNECTING INFRASTRUCTURE OF HIGHWAYS AND RAILROADS AS THE KEY REASON FOR ITS DECISION TO LOCATE IN SOUTH CAROLINA.

AND, THIS NEED IS NOT UNIQUE TO BMW - IT APPLIES TO ALMOST EVERY MANUFACTURER THAT CONSIDERS LOCATING IN SOUTH CAROLINA. THIS STATE DESPERATELY NEEDS AND ACTIVELY PURSUES NEW BUSINESS DEVELOPMENT, AND INFRASTRUCTURE IS THE LINCHPIN THAT ENABLES US TO CLOSE THE DEALS.

BUT WE HAVE WORK TO DO. MANY OF OUR ROADS AND HIGHWAYS ARE IN NEED OF MODERNIZATION. WE HAVE NEARLY 2,000 BRIDGES THAT ARE IN NEED OF REPAIR OR REPLACEMENT NOW AND OTHERS THAT WILL BE A PROBLEM VERY SHORTLY. SOUTH CAROLINA HAS SEVEN TIMES MORE TRAFFIC ON ITS ROADS THAN WE DID IN THE 1950S, AND THIS FIGURE WILL CONTINUE TO INCREASE WITH THE GROWTH OF TOURISM AND NEW BUSINESSES, YET WE CONTINUE TO FALL BEHIND IN OUR REPAVEMENT PROGRAMS.

YOU WOULD THINK THAT THESE KINDS OF TRANSPORTATION ISSUES -- THE SUCCESS STORIES AS WELL AS THE DESPERATE NEEDS -- WOULD BE WHAT PEOPLE ARE TALKING ABOUT, WHAT THEY ARE THINKING ABOUT. BUT THESE REAL ISSUES -- THESE VITAL QUESTIONS -- HAVE BEEN THE CASUALTIES OF OUR RECENT CONTROVERSIES. THIS TOO MUST CHANGE.

THESE ARE CRITICALLY IMPORTANT ISSUES THAT MUST BE ADDRESSED, AND THEY MUST BE ADDRESSED NOW -- WITH ENERGY, EFFECTIVENESS, SELFLESSNESS AND THE DETERMINATION TO MAKE THE MOST OF OUR OPPORTUNITIES FOR GROWTH AND PROGRESS.

WE MUST MOVE FORWARD. BUT IT CAN'T JUST BE CHANGE FOR THE SAKE OF CHANGE. IT CAN'T BE REFORM FOR REFORM'S SAKE. IT CAN'T BE A MEANINGLESS, GOING THROUGH THE MOTIONS, DOING SOMETHING DIFFERENT JUST FOR DIFFERENT'S SAKE. WE MUST SCRUTINIZE EVERY PROPOSAL FOR CHANGE, AND JUDGE EACH ON ITS REAL MERIT.

WITH THAT CRITERIA, WE MAKE THE FOLLOWING RECOMMENDATIONS FOR YOUR CONSIDERATION.

FIRST, WE BELIEVE THE DEPARTMENT SHOULD BECOME THE DEPARTMENT OF TRANSPORTATION TO INCLUDE ALL MODES OF TRANSPORTATION - HIGHWAYS, AIR, RAIL AND WATER. THIS IS THE CASE IN MANY STATES, AND IS, IN FACT, IN KEEPING WITH THE 1991 INTERMODAL SURFACE TRANSPORTATION EFFICIENCY ACT. THIS IMPORTANT FEDERAL LEGISLATION MANDATES THAT TRANSPORTATION BE VIEWED AS A WHOLE, AND WE THINK WE SHOULD ADOPT THIS PROGRESSIVE VIEW. THE IDEA OF HAVING A TRULY BROAD, INCLUSIVE TRANSPORTATION DEPARTMENT WAS ALSO ENDORSED BY THE RECENT STUDY BY THE HIGHWAY USERS FEDERATION WHICH WAS REQUESTED BY THE COMMISSION IN 1991. BY HAVING

ALL MODES OF TRANSPORTATION UNDER ONE UMBRELLA ORGANIZATION, WE CAN MUCH BETTER COMPLY WITH THE FEDERAL MANDATES WHILE IMPROVING COORDINATION AND COOPERATION BETWEEN THE VARIOUS MODES.

SECONDLY, THERE IS THE MUCH DEBATED ISSUE OF THE SIZE OF THE COMMISSION AND ITS FUNCTION. IT'S VIRTUALLY CERTAIN THAT IF YOU ASKED THIRTY PEOPLE FOR THEIR VIEW OF HOW THIS BODY SHOULD BE STRUCTURED, YOU WOULD GET THIRTY DIFFERENT OPINIONS. THERE HAS BEEN MUCH DISCUSSION AMONG THE COMMISSION ITSELF ON THIS ISSUE.

WE MUST NOT BLINDLY OPPOSE REDUCING THE NUMBER OF COMMISSIONERS IF THAT WILL CONTRIBUTE TO RESTORING PUBLIC CONFIDENCE, PROVIDED THAT THE NEW NUMBER FAIRLY REPRESENTS THE PEOPLE OF SOUTH CAROLINA.

HOWEVER, IF THE SIZE OF THE COMMISSION IS DRASTICALLY REDUCED, WE RECOMMEND THAT WE INSTITUTE A CITIZENS' ADVISORY COMMITTEE TO ENSURE THAT WE GET INPUT FROM THE PUBLIC. BECAUSE OF THE EVENTS OVER THE PAST FEW YEARS, THE PUBLIC HAS COME TO FEEL THAT IT HAS NO VOICE IN THE DEPARTMENT. AND, REMEMBER THE OLD ADAGE THAT PERCEPTION IS REALITY. WE MUST MOVE FORWARD AND TEAR

DOWN THE WALLS THAT THE PUBLIC PERCEIVES HAVE BEEN ERECTED BETWEEN THEM AND THE DEPARTMENT. WE THINK THE CREATION OF A CITIZENS' ADVISORY COMMITTEE WOULD BE A STEP IN THE RIGHT DIRECTION.

THE THIRD ISSUE DEALS WITH THE REMOVAL OF THE HIGHWAY PATROL FROM THE HIGHWAY DEPARTMENT. THIS, ALONG WITH THE SIZE OF THE COMMISSION ITSELF, IS THE MOST EMOTIONAL AND HOTLY DEBATED ISSUE. WE ARE VERY PROUD OF OUR HIGHWAY PATROL, AND OUR TROOPERS CAN TAKE GREAT PRIDE IN THE NATIONAL REPUTATION THEY HAVE ACHIEVED AS BEING ONE OF THE BEST IN THE COUNTRY. AND WE ARE CONVINCED THAT THEY WILL CONTINUE TO DO THE SAME OUTSTANDING JOB NO MATTER UNDER WHICH AGENCY THEY RESIDE.

AND EVEN THOUGH WE DO HAVE LEGITIMATE CONCERNS ABOUT THIS POTENTIAL MOVE AND WHETHER IT IS IN THE BEST INTEREST OF THE CITIZENS OF SOUTH CAROLINA, WE ARE WILLING TO ACCEPT IT. WE'RE NOT SURE IT'S COST EFFECTIVE OR WHETHER OR NOT IT WILL INSTILL MORE ACCOUNTABILITY OR EFFICIENCY INTO THE OPERATIONS OF THE HIGHWAY PATROL AND TRULY BELIEVE THAT IT SHOULD BE STUDIED TO BE SURE THAT IT MEETS THE CRITERIA OF

CHANGE BECAUSE IT'S A GOOD IDEA AND NOT JUST CHANGE FOR THE SAKE OF CHANGE. WE WOULD PREFER THAT AN INDEPENDENT, BLUE RIBBON COMMITTEE STUDY THIS ISSUE FURTHER TO MAKE A CLEAR DETERMINATION THAT MOVING THE PATROL IS TRULY THE BEST THING TO DO. WE ALSO FEEL STRONGLY THAT WHATEVER HAPPENS, WE DO NOT ALLOW IT TO TAKE AWAY FUNDS FROM THE DEVELOPMENT AND MAINTENANCE OF SOUTH CAROLINA'S VITAL INFRASTRUCTURE.

HOWEVER, IF THIS MOVE IS DEEMED APPROPRIATE, IF THIS IS WHAT THE PEOPLE WANT, WE MUST NOT OPPOSE IT, BECAUSE, ONCE AGAIN, WE MUST NOT LET THIS -- OR ANY OTHER ISSUE - - DISTRACT US FROM OUR PRIMARY MISSION: MAKING SURE SOUTH CAROLINA'S TRANSPORTATION SYSTEMS MEET OUR NEEDS GOING INTO THE NEXT CENTURY.

BUT, WHATEVER WE'RE GOING TO DO, LET'S MAKE THE DECISION AND BE DONE WITH IT. WE HAVE A JOB TO DO. IT IS TIME TO MOVE ON.

WE HAVE ALSO GIVEN CONSIDERATION TO THE RECOMMENDATION THAT THE MOTOR VEHICLE DIVISION BE MOVED OUT OF THE SCDHPT. AGAIN I ASK THE QUESTION: WHY? IS IT BECAUSE IT'S A GOOD IDEA AND WILL BETTER SERVE THE PEOPLE? OR IS IT BECAUSE IT IS SIMPLY DIFFERENT? ALL CHANGE ISN'T PROGRESS, AND WE MUST BE CAREFUL OF WHAT WE'RE DOING. THE DEPARTMENT HAS FACED THE CHALLENGE OF MANAGING THE MOTOR VEHICLE DIVISION FOR 68 YEARS AND IS PROUD OF THE GOOD JOB THEY'VE DONE. BUT IF IT IS THE RIGHT THING TO DO, WE WOULD NOT BE OPPOSED TO ITS TRANSFER TO ANOTHER AGENCY WITH ONE PROVISION. THAT IS THAT RESTRUCTURING WOULD NOT RESULT IN DIMINISHING THE PRESENT OR FUTURE TRANSPORTATION DOLLARS WHICH HAVE TRADITIONALLY BEEN DEDICATED SOLELY TO TRANSPORTATION PROJECTS. I'LL SAY IT AGAIN: WE CANNOT MAINTAIN AND IMPROVE AN ADEQUATE INFRASTRUCTURE WITHOUT FUNDING. NO ONE CAN.

AND THAT BRINGS ME TO MY LAST, BUT MOST IMPORTANT, POINT. THE INTEGRITY OF THE FUNDING FOR OUR ROADS, BRIDGES AND WHOLE TRANSPORTATION SYSTEM MUST BE MAINTAINED. WE ARE ADAMANTLY OPPOSED TO HAVING TRANSPORTATION FUNDS GO INTO THE GENERAL FUND OR

GOING TOWARD NON-TRANSPORTATION USES. WHEN THE CITIZENS OF SOUTH CAROLINA HAVE ACCEPTED AN INCREASE IN GAS TAXES, IT HAS ALWAYS BEEN WITH THE ASSURANCE THAT THIS MONEY WOULD GO TO A DEDICATED FUND FOR TRANSPORTATION NEEDS. THAT TRUST MUST NOT BE BROKEN.

WHATEVER WE -- OR ANYBODY ELSE -- DO, THE WAYS WE CHANGE THIS DEPARTMENT MUST BE TOWARD PROGRESS, TOWARD A BETTER LEVEL OF SERVICE FOR THE PEOPLE OF SOUTH CAROLINA, NOT SOME KIND OF CLEVER MASQUERADE THAT'S NOTHING MORE THAN A RAID ON THE FUNDS THAT ARE DESPERATELY NEEDED FOR ROADS, BRIDGES AND A TRANSPORTATION SYSTEMS THAT CAN KEEP OUR STATE COMPETITIVE WITH OUR NEIGHBORS AND ENSURE THE KIND OF QUALITY OF LIFE WE DESIRE AND EXPECT. WHEN WE HEAR A CRY FOR REFORM WE MUST LISTEN HARD: IS THAT THE VOICE OF REASON, OR A CLOAKED ATTEMPT TO DIVERT FUNDS?

WITH THAT CAUTION, I'LL END ON THIS NOTE: WE BELIEVE THE SUGGESTIONS FOR CHANGE -- THOSE WE MUST BE PREPARED TO ACCEPT AND THOSE WE MUST ADVOCATE -- ARE WHERE WE SHOULD BE DIRECTING OUR ENERGIES. WE'RE AT

A CROSSROADS. WE HOLD THE POWER FOR CHANGE. WE CAN  
TURN THIS OPPORTUNITY -- ALL OF OUR POTENTIAL AND ALL  
OF OUR POSSIBILITIES -- INTO A SHINING FUTURE FOR  
CITIZENS OF SOUTH CAROLINA.
