The regular monthly meeting of the Department of Transportation Commission was held in room 306 of the headquarters building in Columbia, South Carolina at 10:00 a.m. In compliance with the Freedom of Information Act, the news media was advised in writing of the time, date and place of this meeting.

SECTION 1: The Minutes for the meeting of August 4, 2005; copies of which had been previously mailed to each member of the Commission, were approved.

SECTION 2: On motion of Commissioner Hardee, seconded by Commissioner Truluck, the Commission unanimously passed a motion excusing the absence of Commissioner Harrell.

SECTION 3: The Commission unanimously passed a motion approving the sale of surplus right of way property, as shown in detail in the Appendix.

SECTION 4: The Commission unanimously passed a motion approving the action of the Department in extending bituminous retreatment contracts to include additional resurfacing work, as shown in detail in the Appendix.

SECTION 5: The Commission unanimously passed a motion approving the action of the Department in extending existing construction contracts to include additional work, as shown in detail in the Appendix.

SECTION 6: The Commission unanimously passed a motion approving the action of the Department in extending existing construction contracts beyond the contract limits, as shown in detail in the Appendix.

SECTION 7: The Commission unanimously passed a motion approving the action of the Department in removing roads from the State Highway Secondary System, as shown in detail in the Appendix.

SECTION 8: The Commission unanimously passed a motion approving the action of the Department in adding sections of roads to the State Highway System, as shown in detail in the Appendix.

SECTION 9: The Commission unanimously passed a motion approving the action of the Department concerning projects in the July 12, July 19 and August 9, 2005 highway lettings, as shown in detail in the Appendix.

SECTION 10: On motion of Commissioner Truluck, seconded by Commissioner Hardee, the Commission unanimously passed a motion authorizing the Department to conduct a speed study on US 17 from Gardens Corner to Jacksonboro and further requested the staff to prepare letters to SCDPS and local law enforcement agencies requesting their help in enforcing the speed laws.

SECTION 11: On motion of Commissioner Hardee, seconded by Commissioner Truluck, the Commission unanimously passed a motion authorizing the Department to move forward with an application to the State Transportation Infrastructure Bank in the amount of a \$90 million grant and a \$48 million loan to be repaid from current and future federal funds. If the application is approved, SCDOT will commit up to \$5 million per year for the next 20 years to repay the \$48 million loan from the State Infrastructure Bank. The motion further included a request for the staff to do an analysis on Highway 64 to determine if this is a viable project to pursue in addition to Highway 17.

SECTION 12: On motion of Commissioner Jones, seconded by Commissioner Hardee, the Commission unanimously passed a motion urging the State Transportation Infrastructure Bank to call a meeting to consider the Highway 17 application as soon as possible.

SECTION 13: Commissioner Truluck reported for the Enhancements Committee. The committee requested from the staff additional information on several projects and also requested letters be written regarding projects that have been awarded but have not moved forward noting, that funding could be redistributed if the projects lack activity. The committee will schedule a meeting prior to the next Commission meeting for an update.

SECTION 14: Commissioner Hardee reported for the Mass Transit Committee. The committee met and approved using \$1,099,670 in state funds appropriated by the General Assembly to increase the funding match provided to large and small urban transit systems by 5 percent. The Committee also approved the use of \$1.8 million small urban funds, that was flexed to the rural system by the Commission in May 2005, to fund special requests for one time projects to include the City of Seneca vehicles in the amount of \$250,000 and to fund the vanpool project for five cutaways in the amount of \$350,000.

SECTION 15: On motion of Commissioner Hardee, seconded by Commissioner Turner, the Commission unanimously passed a motion endorsing a resolution supporting enactment of the Passenger Rail Investment and Improvement Act of 2005, as shown in detail in the Appendix.

SECTION 16: There being no further business to come before the Commission, the meeting was adjourned at 12:10 p.m.

Surplus Property Public Notice

September 15, 2005

In accordance with the State of South Carolina Statue 57-5-340, by this publication the Department is making public the Surplus Property Real Estate Transactions to the State Highway Commission. The following sheets include a breakdown of surplus property real estate transactions. These transactions may have resulted from negotiations with property owners during right of way acquisition, direct sales, settlement of a condemnation action, and/or corrective actions to previously reported sales.

1. File 26.112B / SC Route 544 / Horry County / First District

During construction of improvements on Road S-1285 (Jackson Bluff Road), under File 26.729 in Horry County, near the City of Myrtle Beach, the Department acquired right of way for Road S-1285, by Right of Way Easement from International Paper Realty Corporation dated February 21, 1986 and by Right of Way Easement from Grand Strand Water and Sewer dated February 27, 1986.

During negotiations to settle a difficult acquisition case, the Department agreed to convey $\frac{1}{2}$ of the abandoned portion of Road S-1287 (Jackson Bluff Road) adjacent to the Grantee as partial payment for the new right of way needed for the above project. Therefore, a Gratis Quitclaim Deed for approximately 0.20 of an acre of land to Your Basic, LLC was executed on July 14, 2005.

2. File 23.481 / 42.136B / SC Route 14 / Spartanburg County / Fourth District

During construction of improvements on SC Route 14, under File 42.136B in Spartanburg County, near the City of Greer, the Department acquired right of way for SC Route 14, by Title to Real Estate from Clarence L. Neal dated November 5, 2001 and by Title to Real Estate from Willie S. Ross Life Estate, Christine R. Matsko Remainderman, Lois M. Satterfield Remainderman, Catherine E. Byars Remainderman, Charles F. Ross Remainderman, and Wilburn R. Ross Remainderman dated March 3, 2002.

A request was received from the adjacent owner asking the Department to sell the two small uneconomic remainders of Tracts 26 and 28 fronting SC Route 14. The request was circulated to the engineering sections to determine if said parcel could be declared surplus. After review, it was determined that the parcel was surplus to Department needs. Therefore, a Quitclaim Deed for approximately 0.22 of an acre of land to Donald R. Hyde, Jr. was executed on July 22, 2005, in consideration of \$3,500.00.

3. File 32.695 / Road S-66 / Lexington County / Second District

During construction of improvements on Road S-66, under File 32.695 in Lexington County, near the City of Cayce, the Department acquired right of way for Road S-66, by Letter of Dedication from the City of Cayce dated June 15, 1976.

The City of Cayce has relocated a portion of Road S-66 in order to make improvements to the city's sewer treatment plant. The city has requested that the Department convey its interest in the abandoned portion of Road S-66 made surplus by the relocation. In exchange, the city will convey the relocated section of Road S-66 to the Department. Therefore, a Gratis Quitclaim Deed for approximately 4.58 acres of land to the City of Cayce was executed on July 22, 2005.

4. File 32.546.03 / SC Route 12 / Lexington County / Second District

During construction of improvements on SC Route 12, under File 32.546.3 in Lexington County, in the City of West Columbia, the Department acquired right of way by Title to Real Estate from J. Labruce Davis dated June 7, 1974, and by Title to Real Estate from Davis E. Stanton dated May 1, 1974, under Route 12, File 32.546.03.

In the Department's efforts to liquidate its surplus inventory, the subject parcel was listed with a real estate consultant. This very small uneconomic parcel of land was offered to the adjacent property owners with the Grantee making a request to purchase. Therefore, a Quitclaim Deed for approximately 0.03 of an acre of land to James M. Witherspoon and Bonnie M. Witherspoon trustees in trust under the Witherspoon Living Trust was executed on July 11, 2005, in consideration of \$300.00.

5. File 23.613 / SC Route 14 / Greenville County / Fourth District

During construction of improvements on SC Route 14, under File 23.613 in Greenville County, in the City of Greer, the Department acquired right of way for SC Route 14, by Condemnation from Ralph W. Brown Estate dated March 3, 1975.

In the Department's efforts to liquidate its surplus inventory, the subject parcel was listed with a real estate consultant. The property was marketed to the public with the Grantee making the highest offer. Therefore, a Quitclaim Deed for approximately 0.14 of an acre of land to K & L Investments, Inc. was executed on July 11, 2005, in consideration of \$6,000.00.

6. File 23.613 / SC Route 14 / Greenville County / Fourth District

During construction of improvements on SC Route 14, under File 23.613 in Greenville County, in the City of Greer, the Department acquired right of way for SC Route 14, by Title to Real Estate from Willie Mae Norris dated February 19, 1975.

In the Department's efforts to liquidate its surplus inventory, the subject parcel was listed with a real estate consultant. The property was marketed to the public with the Grantee making the highest offer. Therefore, a Quitclaim Deed for approximately 0.15 of an acre of land to K & L Investments, Inc. was executed on July 11, 2005, in consideration of \$6,000.00.

7. File 15.2000 / Road S-21 Relocation / Colleton County / Second District

During construction of improvements on Road S-21 Relocation, under File 15.2000 in Colleton County, near the City of Walterboro, the Department acquired right of way for Road S-21 Relocation, by Title to Real Estate from Walterboro-Colleton Airport Commission f/k/a City of Walterboro and County of Colleton dated October 29, 2002.

The Department acquired 2.7 acres of new right of way from the grantee for \$14,000.00. However, due to problems securing all the right of way for the project the engineers redesigned the road and the right of way acquired from the Grantee was no longer needed. Therefore, a Quitclaim Deed for approximately 2.6 acres of land to Walterboro-Colleton Airport Commission f/k/a City of Walterboro and County of Colleton was executed on August 1, 2005, in consideration of \$13,481.48.

8. File 42.327 / SC Route 129 / Spartanburg County / Fourth District

During construction of improvements on SC Route 129, under File 42.327 in Spartanburg County, in the Town of Lyman, the Department acquired right of way for SC Route 129, from A. G. Jordan by Title to Real Estate dated June 27, 1951.

In the Department's efforts to liquidate its surplus inventory, the subject parcel was listed with a real estate consultant. This very small uneconomic parcel of land was offered to the adjacent property owners with the Grantee making a request to purchase. Therefore, a Quitclaim Deed for approximately 0.17 of an acre of land to William L. and Connie Dunn was executed on August 1, 2005, in consideration of \$1,200.00.

9. File 23.540 / US Route 123 / Greenville County / Fourth District

During construction of improvements on US Route 123, under File 23.540 in Greenville County, in the City of Greenville, the Department acquired right of way for US Route 123, by Title to Real Estate from Lemon C. Galloway, Jr. dated April 26, 1966 and by Title to Real Estate from Alice Wright Jenkins and Grace Wright McGee dated February 22, 1966.

In the Department's efforts to liquidate its surplus inventory, the subject parcel was listed with a real estate consultant to sell. This very small uneconomic parcel of land was offered to the adjacent property owners with the Grantee making a request to purchase. Therefore, a Quitclaim Deed for approximately 0.06 of an acre of land to W.E.D. Properties was executed on July 14, 2005, in consideration of \$6,000.00.

10. File 7.397 / Road S-525 (Dunnagan's Alley) / Beaufort County / Second District

During construction of improvements on Road S-525, under File 7.397 in Beaufort County, near the Town of Hilton Head Island, the Department acquired right of way for Road S-525, by Title to Real Estate from Sea Pines Plantation Company dated April 5, 1977.

A request was received from an attorney asking the Department to convey 390 square feet to his client in order to clear an encroachment recently discovered on Road S-525. The request was circulated to the Engineering sections to determine if said parcel could be declared surplus. After review, it was determined that the parcel was surplus to Department needs. Therefore, a Quitclaim Deed for approximately 0.007 of an acre of land to STD, LLC, a South Carolina Limited Liability Company was executed on August 1, 2005, in consideration of \$1,000.00.

11. File 10.432A / 10.257A / US Route 17 / Charleston County / First District

During construction of improvements on US Route 17, under File 10.257A in Charleston County, near the City of Charleston, the Department acquired right of way for US Route 17, by Title to Real Estate from International Longshoreman's Association dated August 9, 2000.

A request was received from the Public Works Department asking the Department to sell a piece of property essential to their plans to build a new wastewater tunnel. The request was circulated to the engineering sections to determine if said parcel could be declared surplus. After review, it was determined that the parcel was surplus to Department needs. Therefore, a Quitclaim Deed for approximately 1.4 acres of land to Commissioner of Public Works of the City of Charleston was executed on June 2, 2005, in consideration of \$577,000.00.

12. File 32.879 / SC Route 602 / Lexington County / Second District

During construction of improvements on Road S-275, under File 32.352 in Lexington County, near the City of West Columbia, the Department acquired right of way for Road S-375, by Deed to Right of Way from Westside Baptist Church dated June 29, 1953, and by Condemnation from Milton Joyner dated July 21, 1953.

A request was received from the adjacent owner asking the Department to convey any available surplus to use as handicapped parking. The subject parcel was acquired from the Grantee at no cost to the Department and was made surplus by the new improvements on SC Route 602. The request was circulated to the engineering sections to determine if there was any further need for the property. After review, it was determined that the property was surplus to the Department's needs. Therefore, a Gratis Quitclaim Deed for approximately 0.04 of an acre of land to Westside Baptist Church was executed on August 17, 2005.

13. File 10.120A / Road S-1552 / Charleston County / First District

During construction of improvements on Road S-1552 (Lazy Lane Road) under File 10.120A in Charleston County, in the City of Mount Pleasant, the Department acquired right of way for Road S-1552 (Lazy Lane Road) Relocation, by Title to Real Estate from B. J. Rhea dated February 22, 1989.

In the Department's efforts to liquidate its surplus inventory, the subject parcel was listed with a real estate consultant. This very small uneconomic parcel of land was offered for sale with the Grantee making a request to purchase the parcel. Therefore, a Quitclaim Deed for approximately 0.23 of an acre of land to Catherine N. Williams was executed on August 1, 2005, in consideration of \$5,500.00.

14. File 23.771 / Road S-21 / Greenville County / Fourth District

During construction of improvements on Road S-21, under File 23.771 in Greenville County, near the City of Greenville, the Department acquired right of way for Road S-21, by Title to Real Estate from Thomas W. Miller, Lilla Byrum, Stone Miller, May M. Earnest now May M. Miller, William N. Miller, Jr. & Frances Cary Taylor dated September 24, 1976.

In the Department's efforts to liquidate its surplus inventory, the subject parcel was listed with a real estate consultant to sell. This small uneconomic parcel of land was offered to the adjacent property owners with the Grantee making a request to purchase. Therefore, a Quitclaim Deed for approximately 0.18 of an acre of land to James Samuel Cox was executed on August 15, 2005.

15. File 40.549 / 40.412 / US Route 76 / Road S-442 / Richland County / Second District

During construction of improvements on Road S-442 (Munsen Springs Drive) in Richland County, in the City of Columbia, the Department acquired right of way under the Construction Act 824 and accepted into the South Carolina Department of Transportation Highway System on June 18, 1953.

A request was received from an adjacent landowner's attorney attempting to correct encroachment problems. An agreement was offered whereas the Department would deed the subject surplus parcels to the grantee in exchange for a parcel needed by SCDOT for Munsen Springs Drive. Therefore, a Gratis Quitclaim Deed for approximately 0.02 of an acre of land to Hampton Hill, LLC was executed on August 15, 2005 in consideration of \$7,000.00.

3. Abandonment of Right-of-way - Right-of-way may be abandoned if it is determined that the right-of-way is not required for right-of-way proposes or if the right-of-way is not needed for Department purposes.

RESOLUTION

SOUTH CAROLINA DEPARTMENT OF TRANSPORTION

SUPPORTING ENACTMENT OF THE PASSENGER RAIL INVESTMENT AND IMPROVEMENT ACT OF 2005 (SENATE BILL 1516) IN THE CONGRESS OF THE UNITED STATES.

WHEREAS, Senators Lott, Stevens, Lautenberg, Inouye, Hutchison, Rockefeller, and Burns have introduced Senate Bill 1516, the Passenger Rail Investment and Improvement Act of 2005 in the Congress of the United States; and

WHEREAS, the United States Senate Committee on Science, Commerce, and Transportation have marked up the bill and endorsed its favorable consideration; and

WHEREAS, the legislation would reauthorize and reform Amtrak, provide for enhanced accountability, reduce operating subsidies by forty percent, make infrastructure investments that will improve both freight and passenger services, facilitate competitive service, set standards for on-time performance, provide remedies for chronic service delays, and create a new capital program totaling \$1.4 billion over six years for states to improve and start new conventional and high-speed intercity passenger rail services, ~~facilitate competitive service provisions, set standards for on-time performance, provide remedies for chronic service delays;~~ and

WHEREAS, Amtrak's national passenger rail system serves eleven cities and towns in South Carolina, with four daily trains, providing safe, efficient and affordable intercity mobility for hundreds of thousands of South Carolinians annually; and

WHEREAS, South Carolina and its cities and towns have partnered with Amtrak to provide its citizens with higher levels of service, and continues to do so; and

WHEREAS, fifteen chambers of commerce in six states, including those serving Columbia, Spartanburg, Greenville, Greer, and Charleston, have created the Southeastern Economic Alliance to promote the development of high-speed rail across the southeastern United States; and

NOW, THEREFORE, BE IT RESOLVED THAT, the South Carolina Department of Transportation Commission hereby endorses the Passenger Rail Investment and Improvement Act of 2005 (Senate Bill 1516) and encourages the Congress of the United States to enact the legislation; and

FURTHER BE IT RESOLVED THAT, the South Carolina Department of Transportation Commission encourages all members of the South Carolina delegation to the United States Congress to cosponsor this legislation and work industriously for its enactment.
