Oil services industry must reinvent to survive, Schlumberger CEO says

Oil services companies and their exploration and production clients are suffering under a business model that must be reinvented to allow the industry to survive, Schlumberger Chairman and CEO Paal Kibsgaard said. The fundamental problem is the disconnect between oil companies and contractors, with producers developing master plans for new wells and existing operations in-house, then setting up many individual contracts for bits of larger projects, he said. The industry should be "finding ways of breaking with the past and replacing the existing model with a new approach based on collaboration

and commercial alignment between operators and the largest service companies," Kibsgaard said.

Rig suppliers settle in for long crude recovery

The oil market's rebound will be even slower than expected, according to heads of the top offshore drilling rig suppliers and service companies. "I think '16 and '17 are going to be tough," said Transocean President and CEO Jeremy Thigpen, who expects his company will be unable to raise rates for offshore rigs for at least three years. Schlumberger Chairman and CEO Paal Kibsgaard predicted that, in addition, producers will be slow to put rigs back online when prices begin to recover.

\$20B BP oil spill settlement awaits approval

A \$20 billion settlement that would resolve years of wrangling over the 2010 Deepwater Horizon oil spill in the Gulf of Mexico is awaiting endorsement by a federal judge in New Orleans. Federal lawyers formally asked US District Judge Carl Barbier, who found BP grossly negligent in the offshore rig explosion and spill, to approve the agreement between the Justice Department and five states that were affected by the 134 million gallon spill.

Repsol sizing up revival of Buckskin project

Repsol has taken over operation of the Buckskin field development from Chevron and is considering reviving the Gulf of Mexico project. The company said it could decide as soon as the fourth quarter of 2016 whether and how to develop the ultra-deepwater oil and natural gas field. The primary lease term for Buckskin expired in 2014, and an extension for Chevron expired last month. Repsol has sought a new extension, which is under regulatory review.

Oil refineries change focus to cleaner-burning "summer blends"

Oil refineries are gearing up for summer business, slowing production of regular fuels to make way for cleaner-burning "summer blends." The seasonal fuel is mandated by the Environmental Protection Agency to be sold from May to September, said Gregg Laskoski, senior petroleum analyst with GasBuddy.com. "Every year at this time of year, refineries have to produce it. So they're producing

less, and the price goes up," Laskoski said.

Industry ready for new federal gas pipeline safety rules

Newly proposed rules for natural gas transmission and gathering have found little opposition from the industry, which has been anticipating the greater regulatory scrutiny for some time. The proposal from the Pipeline and Hazardous Materials Safety Administration had input from the American Gas Association, which praised the long-awaited rulemaking notice. The American Petroleum Institute and the Interstate Natural Gas Association of America said the industry also is eager to improve pipeline safety.

BLM says court erred in putting fracking rule on hold

The Bureau of Land Management wants a federal appeals court to release a hold put on regulations for hydraulic fracturing, saying a lower court erred when it said Congress has addressed the issue. A district court in Wyoming put the rules on hold based on arguments that Congress expressly prohibited the federal government from regulating fracking. "The district court held that Congress has 'directly spoken to the issue and precluded federal agency authority to regulate hydraulic fracturing not involving the use of diesel fuels.' That was legal error," BLM lawyers argued in their appeal's opening brief.

Pa. lawmakers consider incentives for natural gas use

Pennsylvania lawmakers are considering whether the state should adopt more incentives to encourage the use of natural gas. House Democrats held a hearing on what state Rep. Greg Vitali called "almost a continual stream of bills" seeking to add incentives to use more natural gas within the state for vehicle fuel, heat, manufacturing and power.
