Subject: Treated Like A Common Criminal at SCHAC

SCHAC and Mr. Buxton:

I was treated like a common criminal when no harm was suggested or threats made against anyone at SCHAC. I only made a request to attend SCHAC Board Meeting on 11/20/2014. SCHAC had already informed me that I will be allowed to come but not to speak before the SCHAC Board which was accepted even though dissatisfied. I came to SCHAC and did not cause any disturbances at SCHAC or with any of their employees but presented myself in well respected manner.

I was greeted by several staff members after arriving at SCHAC and allowed to wait in the receiving area before meeting. I was greeted by TJ Sellers (SCHAC Investigator) after being there for some time who stated that he will be back once meeting starts. I saw a uniformed Officer (Larry Walker) came in and allowed to proceed beyond waiting area. TJ Sellers came from a side door and stated to come in and directed me to a seating area where uniformed officer Larry Walker was sitting. I was directed to the seat by Officer Larry Walker and TJ Sellers sat on the other side of me. I stated to Investigator TJ Sellers that my meter needed more money and therefore had to leave. Investigator TJ Sellers came behind me as I got up to go outside and place more money in meter. I came back in and saw Investigator TJ Sellers and Officer Larry Walker standing by door where the board meeting was being held. Investigator TJ Sellers open door and both officers follow me back in therefore taking their seating positions beside me as though I was a common criminal that had to be guarded. Investigator TJ Sellers and Officer Larry Walker both follow me out of the meeting and stood there watching me as I signed out. I felt so humiliated as person that a simple request to attend a meeting became hostile and harassment environment at SCHAC. Investigator TJ Sellers and Officer Larry Walker stood there watching me as I wrote the note and express to Ms. Dorn how humiliated it felt to be treated like a common criminal. I also expressed my concerns to other staff who became aware of my humiliation. I have the right of every citizens to attend public meetings that affects my welfare and others. I requested a sheet of paper from the front desk clerk because Ray Buxton needed to know the humiliation he allowed to happen under his leadership.

I saw vacant seats where SCHAC had their meeting and was not allowed to sit but only in assigned seat established by SCHAC (Ray Buxton) with two law enforcement officers on each side. I did not cause any disturbances during the entire meeting but sat there taking notes. I was still respectful even in expressing my humiliation to SCHAC Staff. I felt disgusting to know that an agency who are supposed to be concern about human rights violated all my basic civil rights. I

not even allowed to move without being guarded. I did not have physical handcuffs or angle braces to see but it was just that. I was not allowed to speak before public board and intimidated by law enforcement when there were no threats of violence of any kind. Ray Buxton and SCHAC did to me as Mr. Turner and SCDEW applying discriminatory practices of the 1960 describing a black man as evil, corrupt, violent, loud with criminal intent because of desires to be not mistreated. I lost all respect for Mr. Turner and the same for Mr. Buxton that sacrifice the integrity of another for selfish gains of keeping position. The specific letter that was presented to front desk clerk for Ray Buxton reads as follow: I been treated as common criminal at this SCHAC Board Meeting by being harass and mistreated by investigator and police officer from SC Bureau of Protective Services. T J Sellers and Larry Walker are officers in this hostile environment. Mr. Buxton, you are being personally responsible and SCHAC.

I will be following a complaint against SCHAC and State of South Carolina for discriminatory practices and violation of my civil rights. I will be submitting this letter, the note for Ray Buxton on 11/20/2014 and list witness such as Sharon Dorn, TJ Sellers, Larry Walker, Daquan and John.

I can not express to you the humiliation, anger, frustration of knowing that SCHAC will commit criminal activity to deny justice in a civil right complaint against SCDEW, SCBCB and Office of Gov.Haley. I am disturbed to know the criminal activity that agency is willing to commit.
