Satisfied with recent federal assurances, South Carolina on Friday dropped a lawsuit intended to save a \$10 billion nuclear fuel factory near Aiken from President Obama's budget ax.

**Note:** The plant has employed about 1,500 people since construction began in 2007, and state leaders say the jobs are important. Gov. Nikki Haley says the federal government should honor its commitment to South Carolina and finish the facility.

The state of South Carolina announced on Friday that it is dismissing its lawsuit filed against the Department of Energy and the National Nuclear Security Administration in support of the Savannah River Site's MOX program.
