As a part of Residents' Rights Month, the Consumer Voice held the annual [Resident's Voice Challenge](#) where residents from across the country submitted stories, artwork, poems, videos, and photos representing this year's theme. In an essay entitled "Who?" resident Dick Weinman describes his experience with caregivers in his facility:

I want the caregiver to approach me as a person, not as a room number, which

had flashed on the screen of her iPod when I called for help. I'd be grateful if she relates to me with "dignity and compassion" - the words that Assisted Living Facilities use to market themselves. I would appreciate an expression of some understanding of what I can't do for myself and need her to do for me.

I quietly fume at caregivers who do their work perfunctorily, disinterestedly, carelessly – caregivers who don't care, or, as one of those who do care said of one of her colleagues, "she doesn't give a rat's butt." Caregivers like that really piss me off.
