Re: FBI Harassment

Dear Governor Haley:

I am new to South Carolina. I came here after a total 20 years of harassment in New York by the Federal Bureau of Investigation ("FBI") and Moody's Investors Service ("Moody's") because I revealed in court documents the unlawful sharing of my medical information that led to discrimination on my job, and because I exercised my constitutional right to represent myself in court, suing the government in 2012 under The Privacy Act for its disclosure of my medical records to my then employer Moody's in 2003. I was constructively discharged from Moody's in 2005.

The government has not stopped its harassment (via computer and phone and stalking) since my moving here, however, which is why I write you. And I write you too because the states where I resided had allowed this same thing, but whom are more "liberal" politically, thereby easily persuaded to collectivize against one whose very complaint would reveal the dangers of what would later become "Obamacare," or, albeit, nationalized medical care. Moreover, as if this were not enough, when I traveled to Canada to get help (surviving on oral antibiotics only and with extreme abdominal pain), the doctor there said to me, "You were followed by the police."

Before I could sue the government, I had to exhaust all remedies by writing to request information under the Freedom of Information Act and Privacy Act, which took well over a 5 year period. (In that time I was assaulted by local police, harassed in my home, and my water and air poisoned by collective consensus that included involvement of my landlords, for which the local police did nothing [even though one admitted to me that I was being harassed because I was on the Internet].) I lost the case in 2014 for failure to state a claim, but enclose one of my documents that I filed with the U.S. Supreme Court, and I do so only to provide background information about the case.

That I lost my case for "failure to state a claim" is common among *pro se* litigants; but that I won in spirit is evident by the continued efforts our government is making to keep me from receiving medical care or employment. The disease I have is rare and not contagious, and it is one I had my entire life [which can be verified by a Canadian doctor with whom I met and was evaluated in 2004]. And I am providing this background since FBI has engaged local law enforcement - in every county I have resided since leaving New York (in particular, Suffolk County, NY [where you may have read in the New York Times about the arrest of the Chief of Police there by the Department of Justice, where mention was made of Suffolk police engaging in unlawful surveillance of residents, and in New Castle, Delaware) - in unlawful

harassment and surveillance, no doubt in retaliation for my suing it. (If there be question as to how I know it is them, let me just say that my paper trail and the amount of contact I have had with them over the years ought to have provided at least some kind of response, which lack of response should in itself be curious given the attached documents and evidence I am providing here that show by computer reports a "FBI MINI" device remotely attached to my computer's operating system.) That is because the crime against me is one so great that the government has not stopped harassing me since my first contact with them in 1997.

As the documents set forth herein establish, I was unable to receive medical care for a burst appendix. As I went from doctor to doctor I realized by what was being said to me that the physicians were denying me treatment collectively at large due to their desire to protect the first doctor who misdiagnosed me. This collective agreement nearly cost me my life. (I survived – barely – on oral antibiotics that I got over the Internet, which at that time was actually very easy to do.) This prompted me to file a complaint with the Department of Justice in 1997, but instead of getting help I was surveilled. To survive a burst appendix is next to impossible. Due to the extreme and bizarre nature of my inability to get medical help, I contacted the FBI, but my medical privacy was betrayed when I began working at Moody's.

Also attached is an Air Report taken at my previous address in New York. This report reveals "gasoline compounds" contained in the air in my apartment, which air quality put an elderly friend of mine in the hospital twice. It is most important to note that this air report – taken with the most sensitive detectors and expansive library of compounds available under the Environmental Protection Agency ("EPA") – was tampered with when my friend inadvertently revealed the name of the laboratory who compiled the report to the landlord (for he did not believe the landlord was involved, although I did), when the landlord – who called very nervous about the fact we took an "air test" of such high quality ("summa canister") – and called the next day to try to get the name of the service that performed the test, but up until the test was taken had repeatedly ignored our requests for help. It is significant also to note that the air test itself was taken **12 hours AFTER** the assault from our neighbors (one of whom worked for *Petro Oil and Gas* at the time [a huge donor to the local police department]) who, on a regular basis, dispensed the gas fumes via the holes via pipes in the wall that divided our respective apartments. I nearly passed out from these fumes and enclose as well the description of what I endured 12 hours prior to when this air report was taken. (As a chemist agreed, the dispensation rate of "propane" is very swift. If the rate of dispensation were multiplied by 12 hours and added back to the time I was first assaulted [at approximately 1:00 am], there would be NO DOUBT of the level of assault I endured.)

The assault of our air quality went on for months, unabated. And we witnessed (while sitting in our car in the front of our apartment, our neighbor carrying a propane tank (covered in part with a cloth) into their apartment. We were also hacked on our computer, which hacking was so intense it destroyed two computers. It was terrifying also to note that the administrative controls were totally taken over at the time I noticed the "FBI-MINI" on the system, and when I asked an Apple representative how it was done was told the "hacker" must be less than 100 feet away.

Now that I am in South Carolina, I am being harassed with the same methods. My DNS ("Domain Network Server") that is provided by the apartment complex is totally hijacked and my Android reveals

that the purported Wi-Fi connection I am told I am on is not the one I am actually on. I am being watched and employment contacts destroyed with the constant harassment.

I therefore write you in fear that this retaliation will not end, and implore you, not only as Governor, but as a conservative and Republican, to put a stop to this by contacting someone you know at the Department of Justice who is also conservative, since I know from my dealings with my antagonizers that all are "liberal" and afraid of what the harassment of me will reveal about what they are doing. I am prevented on contacting conservatives on social media, for example, so I know my antagonizers are liberal. Not only this, but, as we all know, Moody's and the government are very close in their manner of business dealings, as I had witnessed as Executive Secretary at Moody's in the five (5) years I have been there.

Also, I am certain that after my complaint about physicians was made in 1997, the more than coincidental appearance of Jamie Kogan, former assistant U.S. attorney, who became one of my supervisors at Moody's in 2003, and for the immediate harassment I suffered (without provocation) under her supervision, that all these efforts the government is and was making are all due to its need to circumvent Privacy Act Laws, that incidentally are one of the last bastions of protection left that had I been able to get a lawyer to represent me in my case I might have prevailed, but which I did not. I enclose a document produced by Ms. Kogan that literally destroyed my career and prevented me from getting work. This document, dubbed "Paragraph F" in court documents, is filled with lies that FBI will not counter, even though it admitted to having the tape in question. [The FBI involvement is what spurned my need to file suit in court, for I was damned if I did and damned if I did not. I just could not get work. I had nothing to lose with these two powerful entities (Moody's and FBI) against me.] I was devastated, blown away by it. To this day I am still unable to get work and constantly harassed.

I will be filing a complaint with the Internal Affairs office of the Greenville police. I decided I must do so when only yesterday I passed a white truck on S. Main Street with a man in the passenger side who shouted something out to me. I looked over and he tried to hide his face. Then a red light forced the driver to stop and the passenger leaned forward to look at me again. I then caught his face and recognized him as the same man I had seen following me in West Babylon, NY. Obviously, whether one believes it is the government alone, or Moody's alone, or together, it is to be certain that to do what is being done here to me, and what has been done over the years, requires an entity with a LOT of money. That FBI has repeatedly told me on the phone things like, "It's the women doing it to you," and "The liberals don't want you diagnosed" [said to me in and around 2000 when I first started working at Moody's] indicates that they know enough to stop this, and that they do not stop it implicates them. For how can they know so much? And why won't the police help me?

I also enclose my resume to show my employers, in particular Satterlee Stephens Burke & Burke, LLP, who is outside counsel (whom I believe are acting as surrogates to Moody's to deflect Moody's involvement in the harassment) to Moody's and, of course Moody's itself. In my whole career – where I was legal secretary in corporate securities years prior to working for Moody's – I had seen the close relationship between FBI and the attorneys with whom I worked.

Finally, if I could ever get the proper medical tests for my medical condition in South Carolina I would appreciate it, for I cannot get it anywhere else. All this harassment of me began with my asserting a disease in my family that is not treated in the United States. I know from my mother and the doctor in Canada (who told me I was followed by the police) that I am curable. I know too that I can be cured but am being prevented from that cure, all due to the government not wanting me to be well. In fact, all the evidence aside, if the State of South Carolina will permit me to get a diagnosis, this ALONE would PROVE government involvement in destroying my life – like a “bullseye.” It is why the government followed me to Canada, to prevent me from receiving medical care that would potentially reveal the disease.

Anything you can do will be so much appreciated, and I thank you in advance for your consideration to that end.
