Good Afternoon,

Thank you for your help with our TSA Universal CDL Vetting Project. If you were with us, thank you also for taking part in our conference call last Friday afternoon. This note is a follow-up to two of the significant issues encountered on that call.

Many state agencies have indicated that they would like to enter into a Memorandum of Understanding (MOU) with TSA to memorialize the exchange of data and purpose. As a result, we are now crafting a model MOU that TSA will offer for the purpose. If you believe that you would such an agreement would help you to facilitate our request for records, please let us know; we'll forward it when its complete. If you've already sent an e-mail to that effect, you will receive it automatically.

On the subject of MOU's, we have attached to this note a PDF copy of the MOU signed between TSA and FMCSA which provides TSA full user access to CDLIS.

Thank you again for your assistance. We look forward to hearing from you.
