Danielle:

I have to say I am disappointed, but not surprised, by the response from DHEC and DNR. I do not know how the state can possibly claim to own everything seaward of the mean high tide mark and yet not accept responsibility for removing the storm related debris which is in it. This is especially true when the debris poses a hazard to the public which is entitled to use public tidelands pursuant to the Public Trust Doctrine.

We will share this information with the local media (which has a keen interest in this issue), FEMA, local, state and national elected officials.
