Governor, I am writing you for three reasons why I have high hopes that you will be the first person in American history to stop this most horrible, demonically evil, form of religious hatred that is being perpetrated against all observant Jewish Children attending South Carolina's public school system with complete immunity from any legal or social stigma: 1 Because you are the governor, and your office is where this issue properly belongs. 2. Your declared stance on racism: A. when you gave your state of the state address. B. Your speech about the satanically evil event that happened at Mother Emanuel church on June 19, 2015. C. Your speech that you gave on why the Confederate Flag had to come down from the capitol area. D. Your speech when you gave the Republican response to President Obama's State of the State address, just to name a few instances when it was my great pleasure, and a source of great pride to hear you speak. Governor, I am protesting against this ungodly, and unconstitutional attack against innocent observant Jewish children by the state of South Carolina with the only 100% peaceable protest that I can make that will get the state to notice me by withholding my state income taxes. To keep from becoming involuntarily involved in this lucifer conspired law or practice against **OUR CREATOR'S, THE LORD GOD** of our fathers, **OUR ONLY HOLY, ETERNAL, SUPREMELY COMPASSIONATE, ABSOLUTELY-PERFECT BELOVED LORD GOD** of Abraham, the **GOD** of Isaac, and the **GOD** of Jacob (Exodus 3:15, KJV only); **HE IS OUR CREATOR, OUR SAVIOR**, the **GIVER** of all of our days, **OUR ETERNAL KING; CREATOR** of the heavens and the Earth; **CREATOR** of all that is seen and of all that is unseen; **CREATOR** of all that is known and of all that is unknown's, **ONLY HOLY, ETERNAL, COMPLETE, NEVER-CHANGING, LIFE-GIVING, WRITTEN ABSOLUTELY-PERFECT LAWS** is a state law or a state sanctioned practice that is actually trying to make me violate a basic tenet of my Jewish faith, and to prove that I am invoking to my death in my South Carolina's Constitutional right to protest my government's unconstitutional laws or practices by not voluntarily paying my South Carolina's income tax. In my imprisonment and in my protest I will be walking in the footsteps of the all freedom fighters, like Brother Martin Luther, leader of the Protest Reformation in Germany, the great

Mr. Frederick Douglass, the Reverend Doctor Martin Luther King Jr., and President Nelson Rolihlahla Mandela, Ms. Rosa Parks, just to name a few, and without help, Governor, I may not be free again. I do not have a South Carolina's driver licence, or a state issued Identification card, because I consider both to be taxes, and as a result I cannot prove who I am to any banking institution, so I cannot open any bank account nor can I drive myself anywhere. I am not going away quietly because if you type in Thomas Wells on the FEC's home page you will find that I am a candidate for South Carolina's U.S Senate seat, and I am running for the office of the President of the United States in 2016.

Governor, as a very proud Southerner, born here in Greenville, South Carolina, in 1945, I must start off with my most hardy congratulations on your most heroic stance on a most controversial issue of bringing down the Confederate flag. For too many years we, Southerners, have allowed hate groups to wrap themselves in the Stars and Bars so for many years now that flag has become a demonically evil symbol of hatred like the swastika is in my life today. inclusive Word "god" to describe the exact **GOD TO WHOM** I always freely choose to pray and follow, and the reason why I explicitly identify the exact **GOD TO WHOM** I always freely choose to wholeheartedly pray and follow is because I have been commanded, by **OUR MAKER, THE LORD GOD** of our fathers, **OUR ONLY HOLY, ETERNAL, SUPREMELY COMPASSIONATE, ABSOLUTELY-PERFECT BELOVED LORD GOD** of Abraham, the **GOD** of Isaac, and the **GOD** of Jacob (Exodus 3:15, KJV only); **HE IS OUR CREATOR, OUR SAVIOR**, the **GIVER** of all of our days, **OUR ETERNAL KING, CREATOR** of the heavens and the Earth; **CREATOR** of all that is seen and of all that is unseen; **CREATOR** of all that is known and of all that is unknown, to always explicitly identify the exact **GOD TO WHOM** I always freely choose to pray and follow, and that **GOD**

explicitly identified **HIMSELF** in the book of Exodus, chapter 3: verse 15 in the authorized King James' version of the Bible, as to how we, **HIS** chosen people, are to always specifically identify the exact **GOD** to **WHOM** we wholeheartedly freely choose to pray and follow.)

HIMSELF, designed and declared to be our "*special sign*" between **HIM** and us, **HIS** chosen people (Exodus 31: 12-17 KJV only), and our observance is part of our "*special covenant*" between **OUR MAKER**, and us, **HIS** loving and obedient children, and most importantly **HE** gives the punishment for intentionally desecrating our 24 hour observance of **HIS** High Holy Sabbath is death, and death is not as Christians know death, but death is as **HE** said in the Book of Leviticus, chapter 26: verses 27 & 28, where **HE** tells us that if we walk contrary to **HIM** and to **HIS HOLY, ETERNAL, LIFE-GIVING ABSOLUTELY-PERFECT LAWS** then **HE** will walk contrary to us, and we are totally lost without **OUR MAKER**, and we have no salvation without **OUR MAKER, THE LORD GOD** of our fathers, **OUR ONLY HOLY, ETERNAL, SUPREMEY COMPASSIONATE, ABSOLUTELY-PERFECT BELOVED LORD GOD** of Abraham, the **GOD** of Isaac, and the **GOD** of Jacob; **HE IS OUR CREATOR, OUR SAVIOR**, the **GIVER** of all of our days, **OUR ETERNAL KING; CREATOR** of the heavens and the Earth; **CREATOR** of all that is seen and of all that is unseen; **CREATOR** of all that is known and of all that is unknown, because we, **HIS** loving and obedient children, know and understand that all of **HIS HOLY, ETERNAL, LIFE-GIVING LAWS ARE ABSOLUTELY-PERFECT LAWS**, and **HIS HOLY, ETERNAL, LIFE-GIVING LAWS ARE ABSOLUTELY-PERFECT LAWS** that will last throughout all of our generations. So in a nutshell: it is only because of our love, our honor, and our complete devotion to **OUR MAKER, THE LORD GOD** of our fathers, **OUR ONLY HOLY, ETERNAL, SUPREMEY COMPASSIONATE, ABSOLUTELY-PERFECT BELOVED LORD GOD** of the Hebrews (Exodus 3:18, KJV only); **HE IS OUR CREATOR, OUR SAVIOR**, the **GIVER** of all of our days, **OUR ETERNAL KING; CREATOR** of the heavens and the Earth; **CREATOR** of all that is seen and of all that is unseen, **CREATOR** of all that is known and of all that is unknown, is the only reason why observant Jews will not intentionally desecrate our observance of the **LORD'S** High Holy Sabbath, even though it means that throughout their public school experience, and continuing throughout their children's public school experience, they cannot participate in any of the state sponsored sectarian extra-curricular activities, and they are not allowed to make themselves available for those state sponsored scholarships associated with those sectarian extracurricular activities that other children, and their parents show their approval of this form of religious persecution by their physical support of this satanically evil

form of religious persecution. And I call it religious persecution because there are millions of books written about the positive effects these extracurricular activities have on students throughout their whole lives, and the practice of intentionally scheduling these extracurricular activities on Friday evenings and on Saturdays is a sectarian fact, which is how Christians are showing their total arrogance that only their interpretation of which day is the **LORD'S** High Holy Sabbath is to be the only day that is to be officially observed, and by unconstitutionally forcing all observant Jews who believe that in the authorized King James version of the Holy Bible that there is only one, **LORD'S** High Holy Sabbath, and that day is as **HE** personally supervised **HIS** chosen people's personal observance of **HIS** High Holy Sabbath is from Friday evening straight through to Saturday evening has somehow been changed to a Sunday only observance, and the state of South Carolina is currently forcing compliance of a unconstitutional, controversial, sectarian religious practice on all observant Jewish children attending South Carolina's public school system. Again our 24 hour observance of **HIS** High Holy Sabbath is our "*special sign*," (in the Book of Exodus, chapter 16: verses 23 through 31, KJV only) , was designed by **OUR MAKER**, like the *special garments* **HE** designed, our Tallit and our Tifillin (Numbers 15: 37-41 and Exodus 13:9 and 16, Deuteronomy 6: 4-9, and 11:13-22, KJV only) that I wear whenever I am in the public. Of course, these are not all of our *special signs*, and all are part of our *special covenant* that we, **HIS** loving and obedient children, make with **OUR MAKER**. And this law or practice, of scheduling public schools extracurricular activities on Friday evenings and/or on Saturdays is just like when our oppressors in times past, "*outlawed*" the observance of The **LORD'S** High Holy Sabbath. And this law or practice, of public school board members intentionally scheduling public school extracurricular activities on Friday evenings and/or on Saturdays, and why community based organizations who claim to help all children, mean all children except observant Jewish children when they intentionally schedule their sporting events, their plays, and their concerts on Friday evenings and/or on Saturdays. Again this practice or law is against **ARTICLE I, Section 2** "Religious freedom; freedom of speech; right of assembly and petition," of our great South Carolina's Constitution, and thereby violates every state officials "Oaths of office."

Governor, I know that you know that there is a public school here in Greenville, county that has perfected this most hideous form of state sponsored religious hatred to the point that there is not a single observant Jewish child in the whole school, and that school is the Governor's School for the Arts and Humanities, located at 15 University Street. Governor, what kind of humanities are we teaching these future leaders of South Carolina, and of the world? To me we are teaching these future leaders the

humanities of the Ku, Klux, Klan (the KKK). The state of South Carolina is actually following in the footsteps of lucifer's sin of Balaam ([Numbers 22: 5 - 24: 25](#) [KJV only](#)) when Balaam told Balak, king of the Moabites, how to get Israel to sin against **GOD, OUR MAKER, THE LORD GOD** of our fathers, **OUR ONLY, HOLY ETERNAL, SUPREMEY COMPASSIONATE, ABSOLUTELY-PERFECT BELOVED LORD GOD** of Abraham, the **GOD** of Isaac, and the **GOD** of Jacob ([Exodus 3:15](#), [KJV only](#)), **HE IS OUR CREATOR, OUR SAVIOR**, the **GIVER** of all of our days, **OUR ETERNAL KING; CREATOR** of the heavens and the Earth, **CREATOR** of all that is seen and of all that is unseen; **CREATOR** of all that is known and of all that is unknown, **HIMSELF**, thereby causing Israel to get itself cursed. Governor, If we, [GOD'S chosen people](#), intentionally desecrate a most basic tenet of our Jewish faith then we, [HIS chosen people](#), will cause ourselves to be cursed ([Leviticus 26: 21, 23-46](#), [KJV only](#)). I am most proud of our heroic Jewish children that have silently stood-up to this state sponsored religious persecution, and this state sponsored religious persecution is against the very bedrock of what America stands for, by following their Jewish faith, and have individually restrained themselves from enjoying the extracurricular activities that are non-sectarian in themselves except for the time of the week that they are intentionally scheduled makes them unconstitutionally sectarian. Our observant Jewish children and their parents are also intentionally denied the state funded scholarships associated with those sectarian extracurricular activities.

Governor, the type of humanity shown to these innocent observant Jewish children is the same type of humanities shown to Emmett Till in 1955, when a 14 year old Black youth accused of whistling at a white woman was horrifically pistol whipped by two Ku Klux Klanners, Roy Bryant and J. W. Milam, proud members of a local Southern Baptist church in Tallahatchie County, Mississippi. And as the sun was rising above that Mississippi delta area, Emmett, after being pistol whipped all night stood naked a little more than knee deep in the Mississippi river holding that 74lb. gin fan, maintained his unbroken spirit after surviving his demonically evil beating as he proudly proclaimed to J. W. Milam that he was just as good as any white man, and that he had white women in the past. Yes, Roy Bryant and J. W. Milam, took turns pistol whipping the Black youth all night until almost all of his teeth were barbarically beaten out of his head, one of his eyes was horrifically gouged-out, and one of his ears was satanically ripped off of his head. Yes, Roy Bryant and J. W. Milam, were acquitted by a jury of 12 white, local Southern Baptist racist in Tallahatchie County, Mississippi. The real heroes of this story was Emmitt Till himself and Emmitt's mother, Mrs. Mamie Till Mobley, because she would not let that satanically evil,

GOD hating, white Southern Baptist racist sheriff bury her son in an unmarked pauper's grave in the Mississippi Delta, but instead publicly displayed her son for four days in an open casket so that thousands could see exactly what Mississippi state-sanctioned satanically evil, **GOD** hating, white racism is all about in Mississippi. Emmitt Till's satanically evil, kkk inspired murder reignited the then stalled Civil Rights movement in America. Without the state of South Carolina vigorously upholding its own Article I, Section 2 of its own state Constitution; then its inaction is without a doubt a state sponsored, satanically evil, horrifically insane deeds of a ravenous, malignant form of religious racism or hatred; the same type of lucifer inspired hatred that surfaced itself in Mississippi throughout the 1950's and the 1960's, and the exact lucifer inspired evil hatred that surfaced itself in Mother Emanuel church on June 19, 2015, in Charleston, South Carolina. And it is very disheartening to see that we have not learned from our racist past to be able to see our racist actions in the future without someone having to put his/or her life on the line to get everyone to follow our great United States Constitution. I like to quote from the Reverend Doctor Martin Luther King, Jr. When he said in his 1963, Birmingham city jail letter, "*He who accepts evil without protesting against it is really cooperating with it,*" and "*Freedom is never voluntarily given by the oppressor; it must be demanded by the oppressed.*" And also from the Reverend Doctor Martin Luther King, Jr's. speech (*The Casualties of the war in Vietnam war February 25, 1967, The Nation Institute, Los Angeles*) when he said, "*The ultimate measure of a man is not where he stands in moments of comfort and convenience, but where he stands at times of challenge and controversy.*" Governor, if you actually take steps to stop this form of religious hatred then you will be the first Governor in American history to start relieving the yoke of religious hatredism that is being executed against all observant Jewish children attending South Carolina's public schools. These state-sanctioned, racist laws that should have been wiped out with the decisions handed down in the 1954 United States Supreme Court Case of *Brown v Board of Education*. Governor, because of this letter you now know that the benefits of *Brown v Board of Education* as it was to stop all state-sanctioned segregation and state-sanctioned persecution has never been extended to protect our observant Jewish children attending South Carolina's public school system. Governor, I most proudly wear the "Yellow Badge" over my left breast as my way of remembering the more than six million Jews that were murdered simply because of the hatred of their observance of their Jewish faith and I very proudly wear the "Yellow Badge" as my personal statement that I will never idly standby and give my tacit approval of any form of racism. Jude the word that appears on the "Yellow Badge" is a German word that means Jew and it is pronounced *U'da'* and it was spit-out like the "N" word was spit-out by white racist here in America. For too many

years our observant Jewish children and their families have willingly allowed this intentional violation of their written guaranteed rights that are guaranteed in writing in our great South Carolina's Constitution under **ARTICLE I**, Section 2 "Religious freedom; freedom of speech; right of assembly and petition," to be unconstitutionally denied their Civil Rights by school board members that so hate observant Jews that they, school board members throughout South Carolina, intentionally deprive any observant Jew that will not intentionally desecrate a most basic tenet of their Jewish faith, as our Jewish faith appears in the first Five Books of the authorized King James version of the Bible. As you know, our great South Carolina's Constitution under **ARTICLE I**, Section 2 is almost word for word from the First Amendment of our great United States Constitution. Religious freedom is the fundamental principle of all of our civil rights; religious freedom is the very fabric of our society, religious freedom is the very foundation of all of our freedoms, and is why our founding fathers placed securing our religious freedoms in our very First Amendment to our great United States Constitution. Governor, I am sorry that I am unable to make this a simple statement asking you to order all public school board members throughout the state of South Carolina, and all community based activities using public property to practice on or to actively schedule sporting events, plays, or concerts in South Carolina to comply with Article I Section 2 of South Carolina's state Constitution, in that all public schools, and all community based activities using public property to practice on or to actively schedule sporting events, plays, or concerts in South Carolina must reschedule all of these activities away from Friday evenings and from Saturdays, because without this order, you too, are violating your Oath of office thereby making these presently scheduled activities a form of state sponsored, lucifer inspired religious hatred that actually persecutes all observant Jewish children living in the state of South Carolina by forcing them into religious slavery because of the love, the honor, and their complete devotion to

OUR CREATOR; our observant Jewish children have for hundreds of years allowed arrogant Christians in positions of authority to unconstitutionally deny them access to these state sponsored sectarian extracurricular activities, and from being able to compete for the state sponsored scholarships associated with those sectarian extracurricular activities unless they intentionally desecrate a most basic tenant of our beloved Jewish faith.

Governor, if you actually stop these hatemongers, who act with 100% immunity from any legal or social criticism of being religious bigots that intentionally violate both the letter of the law, and the very spirit of our great South Carolina's Constitution, Article 1, Section 2 ([prohibiting religious persecution](#)), and this problem is not only in the South, but in all fifty states; I assure you that if you take on this issue it along with the flag incident you will have proven in your governorship that you are tough enough to handle any controversy that might arise in your term as the President of these United States. I know that you are willing to run as someone's Vice-President, but I hope that it is not Governor Jeb Bush because Governor Jeb Bush is a religious bigot in that he received two such letters from me, and did not have the courage to free the observant Jewish children attending Florida's public schools. And I will call him out on the campaign trail as being an anti-Semite, a religious bigot. Governor, This letter used to be 32 pages long, some of which were talking about the religious wars of hatred that we are fighting against religious persecution between the different branches of the Islamic faiths in Afghanistan, Iraq, Iran, and in Africa, just to mention a few, and several pages talking about why we Jews only have 5 Books to our Bible, and still more pages talking about the fact that we are a country of laws, and our religious freedoms are among the most important freedoms of all, but knowing the need for brevity and to keep this letter to the exact point, but I am not good at that, but I am working on it. The main thing is that school board members throughout the state of South Carolina intentionally scheduling extracurricular activities on Friday evenings and on Saturdays violates their "Oaths of Office," is religious persecution against all innocent observant Jewish children attending South Carolina's public school system, and community based organizations training our youth on how to play

baseball, football, softball, basketball, band or the arts, etc... are in violation of use of public property, and against their "Oath" that they took before they became registered voters in the state of South Carolina, or their "Oath's of Office" that they took before they were allowed to take their public office. Governor, the failure to act, after knowing that law or practice of intentionally scheduling these events on Friday evenings, and on Saturdays violates every South Carolina's public official's, Oath of Office, and knowing this fact and saying nothing, can also be related to the sin of omission. I like the way the Reverend Doctor Martin Luther King Jr. expressed the sin of omission (*which is your failure to act whenever you see evilness or whenever you know that an evil act is about to happen and you say nothing to help prevent that evil act from happening*) when he said, "*He who accepts evil without protesting against it is really cooperating with it.*"

I know that an appointed aid of Governor Haley will be the first to open this letter, and it is my prayer that person will pass this most important letter up the chain of command to reach Governor Haley, herself.
