Here are a sampling of responses and the region of the state. I will send more when I get more.

Michael

Pee Dee - All product for us are coming from our water terminals. We are sending zero trucks to pipeline terminals.

Upstate - Due to an outage at the Buckeye/Spartanburg terminal Regular and Premium gasoline are currently unavailable to load until further notice. We will update when resupply has occurred.

Midlands - overall we are OK today but I am concerned that repairs have not been made, and I still believe it will get worse before gets better.

Multi-Regions - We are seeing several issues:

1. Supply in Charlotte, N Augusta, Spartanburg and Belton is spotty at best. Most major oil companies are 5-14 days out on resupply.

2. Charleston and Savannah demand is heavy, and supply is okay.
3. Stores are getting part loads in order to keep as many from being out for any length of time.
4. Trucking companies are needing 72-96 hour lead time for scheduling.

This is from one the major oil companies with an overall look at the state:

#### Marathon Belton

- Marathon implemented a 100% daily allocation

#### Kinder Morgan North Augusta

- Regular Out now with resupply on 9/20 - allocations are at 85% Spartanburg is available for back up
- Premium out now with resupply on 9/21 - allocations are at 85% Spartanburg is available for back up

#### Magellan North Augusta

- Regular Out now with resupply on 9/21- allocations are at 85% divert to KM North Augusta
- Premium Out now with resupply on 9/21 - allocations are at 85% divert to KM North Augusta

#### Marathon North Charleston

- Have not been made aware of any supply issues by Marathon. Allocations are at 110%

#### Motiva Spartanburg

- Regular potential outage on 9/23 with resupply on 9/26 - Allocations are at 100%
