Post-Brexit Uncertainty May Yield Mixed Bag For UK Courts

The legal uncertainty created by the U.K.'s decision Thursday to leave the European Union reaches all the way to once ironclad litigation rules about forum-shopping and enforcing English judgments across the bloc, and experts say the results could lead to mixed results for U.K. courts.

Brexit Torpedoes Hopes For UK Capital Markets Turnaround

The United Kingdom's shocking vote Thursday to leave the European Union has unleashed panic in capital markets and immeasurable long-term uncertainty that, for the time being, chills any hopes of recovery in Britain's stalled equity-raising environment, experts say.

Bombshell Brexit Vote Creates Whirlwind Of Trade Quandaries

The United Kingdom's stunning decision to decamp from the European Union has the potential to throw decades' worth of firmly established trade norms into upheaval, leaving attorneys waiting in angst for the parties to finalize the particulars of Britain's exit and provide much-needed clarity to the business community.

Bid To Nix Work Permit Processing Deadline Draws Scrutiny

A new rule aimed at increasing job flexibility for some foreign workers caught flak at an immigration attorney panel on Friday, as lawyers expressed concern over a provision that would end the government's requirement to adjudicate work permit requests in 90 days.

Brexit May Lead To More Favorable UK Tax Regime

The British electorate's decision to ditch the European Union could result in U.K.-based multinationals being stripped of some of the protections they enjoy under the EU's umbrella, but experts say Thursday's referendum could entice the U.K. to implement a friendlier tax environment.

4 Remaining Net Neutrality Sticking Points

The D.C. Circuit's sweeping endorsement of the Federal Communications Commission's net neutrality rules has many experts convinced they are here to stay, but the possibility of Supreme Court review and the question of how the FCC will move forward mean the battles are far from over.

Looser Employment Regs, Fewer Workers On Tap Post-Brexit

The U.K.'s decision Friday to leave the European Union could lead to short-term uncertainty and long-term turmoil for employers, experts say, predicting that unpopular employment regulations will be scrapped by reformist lawmakers while new immigration restrictions will dilute the pool of available workers from EU member states.

UK Finance Watchdog Alert For Post-Brexit Rule Changes

The Financial Conduct Authority, Britain's finance watchdog, said Friday after the U.K. voted to exit the European Union that it is keeping a keen eye out for any potential changes to financial regulation, but that rules derived from EU law will stay intact for now.

DC Circ. Suspends New Plant Carbon Rule Briefing Schedule

The D.C. Circuit on Friday granted a bid by opponents of the U.S. Environmental Protection Agency's rule capping carbon emissions from new power plants to suspend the briefing schedule in their case while some opponents appeal the agency's refusal to reconsider its rule.

EPA Fights Industry Bid To Link Mercury Rule Challenges

The U.S. Environmental Protection Agency on Thursday urged the D.C. Circuit to reject a bid by two industry groups to link their challenges of the agency's mercury emissions rule to a new petition taking issue with the EPA's cost analysis of that rule, saying the two cases are distinct.

Calif. Judge Rules Against Water Management Plan For Delta

A California judge on Friday invalidated an ambitious water resources management plan for the Sacramento-San Joaquin Delta, saying that in light of "deficiencies" found by the court, the plan must be set aside until revisions are completed.

Jackson, Miss. Officials Fight State's Takeover Of Airport

Jackson, Mississippi, officials asked a federal court on Friday to block the state from taking control of Jackson-Medgar Wiley Evers International Airport under a new law, which they claim is unconstitutional, establishing a regional commission to replace the Jackson-governed airport entity.

India's WTO Appeal Of US Solar Win Delayed By Workload

Citing a shortage of staff and a glut of complex international trade disputes, the World Trade Organization's Appellate Body said Friday that it will miss an extended deadline to reconsider whether an Indian solar energy initiative unfairly discriminates against foreign companies.

The U.S. Bureau of Land Management urged a California federal judge Thursday to accept its version of a proposed order regarding its decision to continue geothermal leases on California land sacred to the Pit River tribe, saying the tribe wrongly argued that the government is asking the court for an advisory opinion on the leases.

MGM Won't Give Up Challenge To Conn. Tribal Casino Law

MGM Resorts International immediately said it would appeal a Connecticut federal judge's decision Thursday to toss its challenge to a state law that paves the way for the Mashantucket Pequot and Mohegan tribes to open a third casino in the state.

The Federal Communications Commission on Friday unanimously approved a proposal aimed at making Team Telecom national security reviews more transparent and streamlined, including placing a 90-day time frame for the executive branch to complete reviews.

FCC's Wheeler Floats Proposed Rules For Spectrum For 5G

Federal Communications Commission Chairman Tom Wheeler on Thursday announced that he had circulated proposed rules to open up spectrum for 5G applications and flexible use wireless broadband, calling 5G a "national priority," ahead of the commission's July 14 vote.

Consumer, Trade Groups Want FCC Rethink On Lifeline

The Federal Communications Commission was hit with at least six petitions Thursday by consumer advocacy groups, trade associations and others urging reconsideration of reforms to the Lifeline low-income phone and broadband subsidy, especially the new minimum service requirements and rollback of support for stand-alone voice services.

Advocates Question Industry Set-Top Box Alternative Plan

Representatives from several consumer groups — as well as Google Fiber and TiVo Inc. — have told the Federal Communications Commission that an alternative apps-based approach to the FCC's plan to unlock the pay-TV set-top box is a positive move but also one that raises concerns.
