Comments: **1. I fear for the safety of myself, my grown children, my grandchildren and other family members, and our belongings. I, personally, need protection everywhere I go. At restaurant, homeless shelters, at doctors' offices, especially at dentists' offices. For over 30 years, doctors, especially dentists have tortured me with skills and tools of their professions and kept my pain level increased constantly. I desperately need proper reconstructive and cosmetic dental work that will stop hurting. Due to my pass experience with doctors and dentists, I am afraid that I will be left in a comma-toes state and missing my remaining 18 natural teeth, and my 6 tooth upper front bridge.** **2** Individual illegally enter my locked apartment or vehicle during the

When I am gone, and at night when I am asleep, Dental work was performed me on some nights, individuals kept me drugged and stuck me with needles. 4 or 5 times individuals have raped me in my front and/or back in 2014 while I was staying at the Bentley Court apartments in Columbia, SC. **3** Someone else has been using my Dr's license, registration and vehicle insurance and has caused me to have my license

suspended. **4** I would like the return of my papers, books, magazines, and diagrams of the layout of the Citrus of Jerusalem of Zion Project. Some the papers are medical, pertain to a 2012 car accident, ideas for inventions, research project, T.V. shows, business and etc. for every facet of life.

I am desperate need of your assistance. I am disabled, ^{and I} live on a fixed income that is below the poverty income guidelines for the state of South Carolina in which I live. I cannot even afford to buy my discount medications, co-pay for my doctor's appointments, to buy grocery, or to pay all my monthly bills especially my utility bill which controls the heating and cooling in my apartment. I have to pick up food from the local food banks to survive. Now that my licenses are suspended, I am not able to drive to my doctor's appointments or to local food banks for food and etc.

Exhibit 1-A is a copy of an Official Notice from the South Carolina Department of Motor Vehicles (SCDMV) stating that my driver's license was suspended as of December 30 2014.

Yes, I did receive two warning tickets in July 2014 while I was homeless living in my van.

Since the date was July 7, 2014 and not August 1, 2014, my vehicle registration had not expired yet.

I was not aware that someone had stolen my vehicle registration from my van until the officer asked to view my vehicle registration. After speaking to the officer, I immediately paid my vehicle taxes and received a new vehicle registration which is exhibit 2.

Because someone(s) stole my copy of the tickets from my van I am not able to exhibit them so that others can see that my tickets had the word warning written on them.

Exhibit 2 is a copy of my vehicle tax receipt dated July 7, 2014 and a copy of my South Carolina ~~document~~ of Registration.

Exhibit 3 is an official notice from SCDMV asking me for proof of ^{my} vehicle insurance which I provided to them after speaking ^{to} the Mr. Belton and ^{to} Mr. Waterfield at the South Carolina Department of Insurance to make sure that I had insurance on my vehicle. Mr. Belton is the attorney at the South Carolina Department of Insurance and his contact number is 803-737-6158. Mr. Waterfield is the investigator at the South Carolina Department of Insurance and his contact number is 803-737-6191.

Also stolen from my van was a letter that I received about the same time I received **Exhibit 3**. I took **Exhibit 3** with me to the Municipal Court and file a Motion to re-open case number 44999GQ. **Exhibit 4** is a copy of the Motion to re-open ^{Case} number 44999GQ which has the following it;

1. The received date of September 8, 2014 at the top right hand corner which is the date that I submitted this form.
2. The received date of September 10, 2014 at the left bottom corner with the initials that look like MA.
3. The words CRIMINAL CASE listed under the case number. I think that the words traffic ^{traffic} case or court should be written in the place of the words criminal case.
4. **The Presiding Judge list on the Motion to reopen is Judge Kristy Grafton Goldberg. I assumed that I would have Judge Goldberg for the motion to re-open. case number 44999GQ**
5. **There is not a Judge's signature on this form**
6. **This form states that the officer was present. The officer did not attend court when I appeared in court.**
7. **This form states that the defendant was present** ^{The white female who gave me a warning ticket on 7/7/14 did not appear in court on 12/29/14.}

Exhibit 5 is a city of Columbia Municipal Court Case History for case 44999GQ dated July 8, 2014. The judge name on this history is Judge Dana D. Turner and it states the following;

1. I was charged for failure of proof of insurance on my vehicle not for a missing registration
2. On 7/7/2014 there was a TIA Guilty Bench Trial, ^{on the date that I received the ticket.}
3. The Disp. Date of 8/14/2014.

4. I am being charged with a fine of \$237.50

Exhibit 6 is a City of Columbia Municipal Court Summons dated September 23, 2014 that I received in court on October 29, 2014.

Exhibit 7 is a verification of court attendance that I asked a ^{court} officer to give me after I received **exhibit 6** and realized that it was October 29, 2014 and that I had just left a court proceeding.

I did appear before a judge on October 29, 2014. I took the following items with me to show the judge:

1. My driver's license which was valid until December 30, 2014.
2. **Page 1 of Exhibit 8** which includes a copy of my South Carolina Insurance Identification card from Titan Insurance which is underwritten by Victoria Insurance.
3. Exhibit 2, a copy of my vehicle registration dated 7/7/2014.

I did inform Judge Dana A. Turner that I had only received a warning ticket as I attempted to show her my information.

Judge Turner ignored me and informed me that I owed \$237.50 for court fees and that I could set up payments.

I asked Judge Turner if I could volunteer at a non-profit instead of paying the fine.

Judge Turner: No, but you can follow one of these officer and start making payments.

I followed and officer out the court room and asked for a copy of all the papers about my court hearing. I then tried to make a motion to appeal the judge ruling an employee in the Municipal Court office. I was told that I needed a copy of the ticket and that the court clerk had a court of the ticket.

Court Officer: You will have to wait until the judge finishes with her other cases.

I waited until Judge Turner had spoken to everyone who had to appear in court.

I then asked Judge Turner for a copy of the ticket which I was told that I needed to appeal the fine.

Judge Turner: You cannot appeal the fine but you can appeal the motion not to re-open the case.

Since my mail was getting forwarded to my new address listed above, 1002 Old Manor Road, Columbia, SC 29210 from my Post office Box 7011, Columbia SC 29202 listed of my SCDMV Notice of Driver's license suspension. I received **Exhibit 1A** on December 30, 2014 or December 31, 2014 from my mailbox. Thus I had to wait until January 2, 2015 to contact SCDMV.

On **January 2, 2015**, when I called the **SCDMV**, Chris with the employee ID# 321 answered. I also called the SCDMV and spoke to Chris to confirm this information before I send it to you.

Chris informed me that the **following information about my tickets was located on their computer;**

1. That I received two tickets on July 7, 2014
2. One ticket has the number **44998GQ**, and this ticket was issued because of expired vehicle license/tag. This ticket also has a fine of \$237.50
3. One ticket has the number **44999GQ** and this ticket was issued for non-proof of vehicle insurance.
4. That I would have to pay the \$237.50 plus \$100 for each ticket to have my driver's license re-instated.

Please compare Exhibit 1A and Exhibit 3. These exhibits which are Official Notices are supposed to both be from the SCDMV has the following ; (You can also use the information on these Official Notices to locate their existence at the SCDMV and at the City of Columbia Municipal Court).

I am not sure what SV means at the top of Exhibit 3, but I do have a white 1997 Pontiac Transport Van.

Chris, employee number 321 at the SCDMV, stated that ticket no. 44998GQ is the ticket that has a fine of \$237.50 with it.

Both of my Official notices from SCDMV has the ticket no. 44999GQ on them.

A question that I would like to have the answer to is, if both Exhibit 1-A and Exhibit 3 are Official Notices from the South Carolina Department of Motor Vehicle, why wasn't Both Exhibit 1-A and Exhibit 3 mailed form the SCDMV headquarter's office in Blythewood, SC?

On page four is a shorten version if my driver's license situation in order that these negative happens occurred. Following the short list, are the following;

1. A list of things that I am certain occurred, even though, my copies of the warning tickets were stolen from my van.
2. I list of items that I desperately need your assistance with.
3. A Exhibit list
4. A list of items/papers stolen from my van while I was homeless and that pertain to the legalization of my van.

A Short version of the events are as follows;

1. I received two warning tickets.
2. I had to appear in court for a warning ticket
3. I received a fine for a warning ticket after appearing in court with papers legalizing my vehicle.
4. I was denied the opportunity to service at a non-profit in place of the fine.
5. I got my driver's license suspended as December 30, 2014.
6. I must pay \$237.50 plus \$100 for each of the two warning before my driver's license can be re-instated.

I am certain of the following;

1. That I received the second warning ticket on July 7, 2014
2. That the officer stated that she was giving me a warning ticket because I could not show her a copy of my vehicle's registration.
3. I received my first warning ticket two or three days before I received the second warning ticket on July 7, 2014.
4. I received the first warning ticket at night, and the officer stated that one of my headlights was not working.

What I desperately hope that you can assist me with getting my driver's license re-instated;

1. **To be found not guilty, because I received warning tickets.**
2. If I am not found un-guilty, then I would like the opportunity to volunteer at a non-profit in place of the \$237.50 fine that I received because I cannot afford to pay the fine and I want my good driving record back;
 1. The date that I was stopped was July 7, 2014, and the police officer should have been able to obtain information about the legalization of my vehicle by her computer, police radio and/or by telephone at the time that I was stopped even though I did not have a copy of my registration.
 2. My vehicle was legal and my vehicle had insurance with a proper registration.
 3. My driver's license was valid.
 4. After I received a new copy of my vehicle registration I went to the court house With my registration, vehicle insurance information and my driver's license.
 5. In the court session that I attended on October 29, 2014, I informed the judge that I have the following and attempted to show them to her; 1. My driver's license, 2. My vehicle registration, A copy of my vehicle insurance information
 6. In my court session that I attended on October 29, 2014, I asked to receive community Service in place of the fine.
 7. Please contact Vocational Rehabilitation so that they can provide me Transportation on the Dart Van to and from the non-profit that I am assigned to volunteer at.

The following items don't pertain to getting my driver's license re-instated, but I need your assistance with obtaining them;

3. **Getting a homeless prevention program to pay utility bill, and rent portion for a couple of months** until I can get Vocational Rehabilitation to send me to college. My utility bill was \$215.06 for January 2015. I also had a partial payment of \$56.39, see exhibit 9. All of the non-profits that I have asked for assistance me by paying my utility bill has always denied me and state that they cannot assist/pay my utility bill unless my services have already been disconnected. I don't under that because what little food that I have in the refrigerator will be spoiled by the time I get to their office.

4. I am not sure if I qualify for a utility allotment through a program, but I have never received one through Housing Authority where I receive my Section 8 voucher.
5. Also I was informed that utility companies could not disconnect their services from disable individuals as myself is this a true statement? If so, how can I make this a reality for me? I am disabled with paranoid schizophrenia which has painful symptoms of many illnesses including arthritis and fibromyalgia.

6. Please monitor me and assist me in getting the proper dental care that will include Re-constructive and cosmetic surgery. I have been going to different dentists since about 1983, Trying to alleviate pain and trying to save my teeth. I now suffer with myofacial pain syndrome With increased sinus headaches and migraine headaches that turn into cluster headaches When I am stressed. I only have 18 natural teeth left. 16 of these teeth extend above the Gumline, two of the 18 are attached to a six tooth bridge in the upper front of my mouth, another two have broken off in my gum.

I did try to receive dental care before my teeth broke off in my gum but I could not A dentist who would perform dental proper dental work on my teeth, not even a dentist with my Medicare Advantage Plan part C through America's 1st Choice. I have spent about \$10,000 of my personal money and that does not include what my Medicare Advantage Plan part C and Medicaid has paid on my behalf.

This is the name of a government funded program and contact numbers to a program That is supposed to do the reconstructive and cosmetic dental work that I need for free.

Donated Dentistry Program is located in other states. I would like to go to an office in another states, since someone has all the dentists that I have visited for dental services in South Carolina trying to make me loss all of my teeth and all my thinking sense.

I think individuals are taking my letters out of the post office because I have written The White House and several other people for assistance several times and I have not heard back but once. I don't think I was able to use the answer I received to help me.

7. I need your protection for my personal safety. Individual(s) are constantly entering my apartment, vehicle and my assigned place when I stay at homeless shelter to steal, and vandalize items. Most of the time they steal my personal information like my driver's license , post office key, social security card, Medicare Part A and Part B card, my Medicare Advantage Plan Part C and Part D card. My Part D is through Humana which someone else took control over the first day I enrolled in it about three years ago.

Individuals also come into my apartment and private spaces to make sure all the food items and medication that I take is tainted. When I live at a homeless Shelter whether in Columbia, South Carolina or Altanta , Georgia, people always get the kitchen staff to taint my food.

During the early months of 2014 while I was staying at 1304 Bentley Court Apartments individual came into my apartment in the middle of the night several times and did dental work on my number 16 tooth location and possible other teeth. ^{The only door to my apartment was locked and I even had maintenance to install a barrel bolt lock.} I was drugged in some type of sleeping spell. I am not sure how many days I was under to spell.

When I came through enough to wake up, I was aware that I was naked, and that the people who did the dental work left me in more pain.

About four times while I was under this sleeping spell, someone tried to rape me. I tried to come conscious but I could not. I could just barely feel them touching my front private part twice, and my rear once.

After one attack, someone came in fussing saying "Get up and wash" repeatedly while hitting on the head. I woke up like a robot and took a bath. Put on some clothes and got back into the bed. I don't even know how long I stay asleep this time. I do remember people saying to me, "Don't get up and my spirit of me and the spirit of others would leave me".

They had a drill playing most of the time so that I could hear it all night and all day.

One reason that this dental work was done at night is to make me frighten of going to a dentist and to drive into a severe mental state and/or to make me have a heart attack. I not sure Which of the following that these people want more;

1. The drawing to the plans of the Holy cities of Jerusalem of Zion that I had hanging on the wall
2. My business ideas
3. My plans to help African and other three world countries
4. My titles as a National Prophet which comes with benefits .
5. The use of all the government benefits that I qualify to receive by my present income status like Medicare, Medicaid, food stamp which I keep getting denied from receiving and countless other programs.
6. My grades from Florence Darlington Technical College to transfer to another college to steal Grants and loans.
7. Do they want the in heritage that my natural father, Willie Gene Jacobs left for me?
8. The power to control me, my children and my other family members.
9. Or if they want the dental work out of my mouth. Dr. John Whittington of Marion,

South Carolina was the dentist who put the metal dental bridge in the upper front Of my mouth. I can go into any government building and the metal detectors do not go off.

So that means that the people working in the government for been watching me and monitoring my actions for a lot of years. Maybe even since when I had surgery on my head as a small baby.

Now all the American citizens, and everyone in the whole world will be what type of people control the United States of America. If America is the home of the free, then why am I trapped in pain? If America is the home of the brave, why would people with weasel personalities sneak into my apartment in the dark night while I was drugged and do painful dental trying to put me into a comma?

Someone even gave me papers to complete for residence in a nursing home and/or a mental institution.

I have 18 natural teeth left and I want to keep all of them when I have my dental work done.

I know that it sounds strange that someone wants my teeth out of my mouth to put them in their mouth, but it is true. Someone wants to take my place as the national prophet which is why I am arranging a meeting with the President and the Vice-President of the United States. Just like you see on detective shows, dental work is used to identify people and my dental work is what people are trying to frighten me out of first. There seems to be a lot of Delilah Whites in the United States, and probably other countries lining up to gather up my blessings from the Lord God.

At this meeting in Washington, I am supposed to be given me a documentation stating that I am the National Prophet. If I don't receive such receive such a document from President Obama or Vice -President Biden, I will need assistance in prevent others from using my information about the Cities of Jerusalem of Zion/plans for a chain of Holy communities until I can find a legal way to obtain a document naming me the National Prophet. I have found so many different non-profits in the United States and in other countries that use government funding from the United States which I can use to build the Cities of Jerusalem of Zion. One of those semesters was my first semester in college, and the other semester I was on the President's list. Yes, I do have to study more than other people and I have to keep reading and re-reading my work, but I can learn. I need to obtain training in a career that is sedentary and soon so that I can avoid getting farther behind on my bills which includes a student loan that I am trying to re-enroll in deferment again.

10. There is a program called the Central Midlands Council of Government, and this program has sub-program called Midland's Share a Ride Program . This program offers free rides to the disabled. Bob Mariona is over the program. The address for the program is 236 Stoneridge Dr., Columbia, SC 29210, and the telephone number is 803-376-5390.

I contacted this program for transportation since my driver's licenses are suspended. When I contacted Midland's Share a Ride Program, Carol Boykins informed me that the funding for their program was discontinued by the Lt. Governor's office in the fall of 2014.

Can you possible get this program refunded so that disabled individuals like me can have some type of transportation? Some individuals, as myself, find it difficult to walk to the bus stop, and to walk to and from the distances to their stop locations from the bus stop.

Disabled individuals, as myself who have only Medicare cannot use Medicaid transportation for medical visits.

I hope that I can depend on your assistance when I get my health issues under control. There are several non-profit programs that I would like to start under my church. Having a transportation program for the poor, disabled, and disadvantaged individuals is one program. I also want to extend the places that the transportation will take individuals like to the grocery store, the post office, the library, to school, and to church.

And I would like to make sure that my non-profit can distribute the \$3 bus passes to pay for transportation on the Dart for disabled individuals as non-profits should be doing now. The Dart van charges \$3 for each stop or one way.

11. Check with the Social Security office and find out if I am supposed to be receiving an extra \$200 per month with my \$1290 income per month from Social Security. The telephone number to the Social Security office is 1-800-772-1213. My Social Security # is 251-21-3209 and my birthday is 04/30/1960.

12. If so, how long have these individuals been taking \$200 from my Social Security /disability monthly income and how long have they been receiving a disability check(s) in my name?
13. If so, did these individuals also take money from the checks of my three children, Alexander D. White, Cicely I. White and Timothy I. White when I was receiving a check for them from Social Security as dependants of mine. The last dependant check that I received was in March 2008, Timothy's birth month or June 2008, the month Timothy graduated from High school.

I would like to suggest that you check every Social Security office in the United States and other countries. These individuals might still receive dependent checks in my name for my children,, Alexander Dewayne White, Cicely Ivori White, Timothy Isaiah Lord White.

I have never receive a Social Security check for the following people, but might be a good idea to check the Social Security office to make sure no one is using the following names or deviation of their names to receive money illegally especially since pernicious is commonly diagnosed as paranoid schizophrenia ; my daughter-in-law, Neekeda Denise Paige White, my daughter's common law husband, Marcus Peebles, his children and my grandchildren Nicholas White, Alexia White, Jordan Evans, Zachariah Peebles, and Benjamin Peebles.

14. Assistance getting an apartment or house with my Section 8 voucher that has the following;
1. A flat or one step entrance verse flight of steps that lead into the residence. I have two flights of steps that I must walk up and down to enter and existing my apartment.
 2. A washer and dryer connection. I have asked the Brairgate Condominiums which I live in to let me more into another apartment as the manager, Heather who accepted my application said that she would do.
