I am signing this because my children and I too went through this trauma. Thankfully, they were only out of my arms for three months but we are scarred for life. My middle daughter had been diagnosed with Chronic Migraines, Idiopathic Gastroparesis, and a pretty severe Vitamin D deficiency. However, it was argued by the courts that this was not Rickets because her legs were not bowed (even though she had all the other symptoms of Rickets) and 'everyone' in our area tends to have an abnormal Vitamin D level. The courts said she was just too sick for these diagnoses and because they could not find a cause (not that they were actually trying to find one), obviously I was the one either making her ill or exaggerating how ill she really was. Since that time, she (as well as other family members) been diagnosed with a genetic disorder called Ehlers Danlos Syndrome (EDS), Postural Orthostatic Tachycardia Syndrome, Vasovagal Syncope, Distal Loop Renal Metabolic Acidosis, and much more...all of which are common co morbidities of EDS. She too has had fractures and what has appeared to be fractures on xrays. But none of this is related to abuse in any way! We are medical Zebras. We are not the norm so doctors must treat us differently and in sometimes novel ways as there are little to no studies done on treating us. The Walls family has already been scarred by doctors and courts that are too arrogant or blind to see beyond their own noses. Do the tests and

the REAL research! You must prove beyond a shadow of a doubt. And there is some serious doubt in their case! Let the poor little MacKenzie go home to her mommy and daddy where she belongs before the scar in her soul is so deep it will never heal!
