### **Highway Signs**

1. Myrtle Beach 501: Tanger has submitted an application. If possible, please expedite the application for signage on Highway 31 north and south bound.
2. Myrtle Beach 17 : Application has been submitted - there are spacing issues so we are on a waiting list - check the possibility of adding more panels to the current sign.
3. Charleston: I-526 east and west bound - no space available on current sign, cannot build additional structures - check the possibility of adding more panels to the current sign.  
I-26 eastbound - no space available on current sign, cannot build additional structures - check the possibility of adding more panels to the current sign.

### **Visibility**

1. Charleston: I-26 - visibility to the Centre Point Sign on I-26 is impaired by foliage--can it be thinned to enhance visibility to sign
2. Charleston: Visibility to Centre Point sign on I-526 is impaired -can it be thinned verify that clearing and maintenance of the tree line is part of the residential development that is scheduled to start in 2014.
