## Commission on Higher Education

### Agency Budget Requests for FY 2007-08

The Commission's agency budget request priorities for FY 2007-2008 represent, in part, how the Commission plans to address some of the important issues facing the higher education community in South Carolina. These priorities are part of the Commission's continuing efforts to align available resources to our stated goals and objectives. The requests below represent a 2.4% increase in CHE total general fund appropriations in FY 2006-07.

<sup>2</sup> In concert with this funding request, CHE requests a proviso directing any new funds for the Access & Equity program to be allocated through a competitive grants program. CHE plans to orient this program to assist in efforts to increase minority and underrepresented populations in nursing and health care.

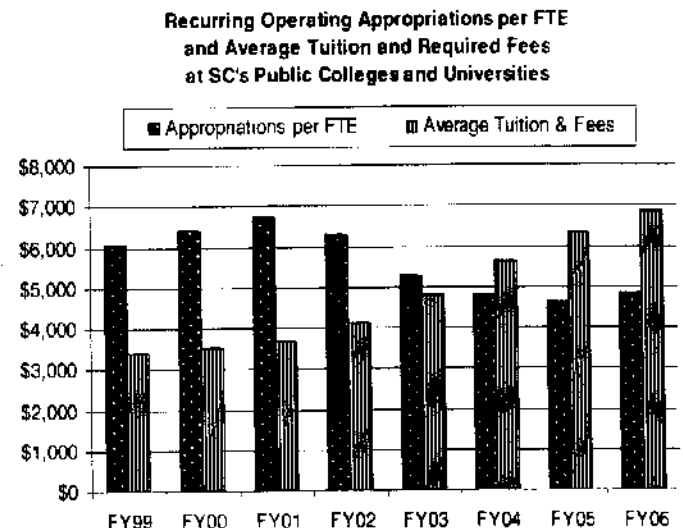
## Operating Funding for Higher Education

Higher Education's greatest need is for increases in operating funds to pay for full-time faculty and to reduce dependency on tuition and fees to replace state operating appropriations. As a related issue, there is growing concern regarding inequity in state funding across institutions that evolved unrelated to institutional performance.

State funding for the operation of public colleges and universities (i.e., recurring base funding) declined from \$781 million in FY 2000-01 to a low of \$606 million in FY 2003-04 – that represents a 22% decline in just three years.

*A recent national report indicated SC experienced the single largest decline at 27% in state funding for higher education during the 2000 recession.*

In FY 2006-07, higher education operating funding at just over \$688 million still remains \$92.6 million below FY 2000-01 funding levels. Recent increases are largely attributable to pay and health plan increases provided by the state.



Since FY 2000-01, enrollment continues to increase as does the cost of goods and services which places greater pressure on institutional operating funding. Full-time equivalent (FTE) enrollment in public institutions grew by 17% from fall 2001 to fall 2005.

If South Carolina had been able to keep pace with inflationary increases for higher education since FY 2000-01, our higher education operating appropriations today would stand at \$998 million or \$309 million (28%) higher than current appropriations.

CHE is advocating for \$45 million in educational and general recurring operating funding across our public colleges and universities for FY 2007-08. The requested increase of 6.5% represents the higher education price index (HEPI) in 2006 of 5% plus 1.5%.

CHE also supports annualizing \$30,517,840 in one-time FY 2006-07 funding received for on-going operating activities.

The requested funds will help mitigate the need for further tuition increases and will enable a portion of the current inequities to be addressed provided institutions continue to maintain acceptable performance levels.

**STATEWIDE ELECTRONIC LIBRARY ..... CONTINUATION OF \$2,000,000**

The statewide higher education electronic library has received a non-recurring appropriation of \$2 million in each of the three most recent fiscal years. CHE, along with higher education, requests continued recurring support.

This important statewide project is a cooperative and collaborative effort among our state's 58 public and private higher education libraries. It allows central purchasing and licensing of essential electronic academic journals and related databases - an effective and efficient way to equalize access to new resources statewide and level the playing field for smaller higher education institutions, while helping larger institutions fill research gaps by expanding access in core undergraduate areas. The project also enables extremely cost-effective collection sharing by connecting our public and private higher education libraries and the State Library in a catalog and delivery system.

**NEED-BASED GRANTS.....REQUESTED INCREASE OF \$10,000,000**

Financial barriers often keep many qualified students from enrolling in higher education. Investing in our state's neediest students helps those capable of earning degrees, but lacking necessary financial resources. Our state as a whole benefits as increasing educational levels assists in increasing in per capita income and our state's competitiveness in the global economy.

Current funds are not sufficient to reach all eligible students or provide maximum allowable awards. In 2005-06, there were 15,282 awards at public institutions with an average award of \$1,158 and 11,904 awards averaging \$358 at independent institutions. Based on the number of awards in 2005-06, the requested increase translates on average to increases of \$524 per award at public institutions and \$168 at independent institutions.

Need-Based Grants was the only undergraduate scholarship/grant program not receiving increased funding in FY 2006-07. The imbalance in merit-based and need-based student aid is growing. Need-based grant appropriations represent only 9% of state scholarships/grants funds at public institutions. Factoring in Tuition Grants for independent institutions, the state's need-based programs make up only 18% of state-funded undergraduate student aid.

Over the most recent five years, funding for merit-based programs (Palmetto Fellows, LIFE, and HOPE) has grown from \$67 million to \$166 million, a 147% increase, with the average award increasing from \$2,919 to \$4,569. During the same period, need-based funds increased 83% from \$12 million to \$22 million, with the average award, including public and independent institutions, increasing from \$606 to \$807.



## SC Education Lottery

### Continued Funding of Higher Education Programs with Lottery Proceeds

Below, the higher education items funded by the S.C. Education Lottery in FY 2006-07 are listed. The Commission requests continued funding of each of the existing programs and **requests an increase of \$10 million for Need-Based Grants and restoration of program funding in the amount of \$1.5 million for the Teacher Education Grants program.**
