Hi Christian,

In response to your question below, S. 261 increased revenue \$3,144,803 for FY 14, so if we lowered the 7% rate to 6.99209%, it would reduce individual income tax revenue by \$3,145,000 and effectively make the bill revenue neutral. The impact would affect different taxpayers as you noted. Please let us know if you have any questions.
