SECTION 2: The Commission unanimously passed a motion approving purchase orders issued for amount in excess of \$10,000.00 during the month of July 1992, as shown in the Appendix.

SECTION 3: The Commission unanimously passed a motion authorizing the Department to enter into Supplemental Agreement No. 11 with Johnson, Knowles, Burgin and Bouknight for additional engineering services for the I-20 Rest Area Project in Lexington County at an estimated cost of \$17,050.00, as shown in the Appendix.

SECTION 4: The Commission unanimously passed a motion authorizing the Department to enter into a contract with Post, Buckley, Schuh & Jernigan, Inc., in the amount of \$918,074.79, as shown in the Appendix.

SECTION 5: The Commission unanimously passed a motion authorizing the Department to enter into an agreement with Russell-Veteto Engineering, Inc. to perform underwater bridge inspections in various counties in Districts 2, 3, 4 and 6 at an estimated cost of \$249,073.62, as shown in the Appendix.

Pursuant to the Commission's previous action of July 18, 1991, authorizing the Department to seek Consultant Services to replace to US 17A/SC41 bridge over Santee River in Berkeley-Georgetown Counties. The Department has entered into a contract with Post, Buckley, Schuh & Jernigan, Inc., in the amount of \$918,074.79. Work is to be funded under the FBRR Program.

Contract - Underwater Bridge Inspection

Pursuant to the Commission's previous action of December 19, 1991 authorizing the Department to seek consultant services to perform underwater bridge inspections in various counties in Districts 2, 3, 4 and 6 the Department has entered into an agreement with Russell-Veteto Engineering, Inc. in the amount of \$249,073.62. Work is to be funded under the Federal Aid Bridge Replacement Program. Increase in the contract amount is due to diving of additional bridges.

SURPLUS RIGHT OF WAY PROPERTY - LAND

In 1959 during acquisition of right of way for construction of improvements on Road S-256 in Beaufort County, under File 7.327, the Department acquired right of way from Shell Point Subdivision by Right of Way Easement, dated February 9, 1959.

During the recent settlement of a condemnation case by our Legal Section for right of way needed from Tracts 50-53, 57-59 and 62 for construction of improvements on SC Route 802 and SC Route 280, under File 7.439, the determination was made that a portion of the above referred to right of way was no longer needed and could be relinquished to the adjoining owner. Therefore, a gratis quitclaim deed conveying an approximate 0.25 acre parcel of land to Alan A. Cardinale was executed on July 21, 1992.

This matter is reported to the Commission in accordance with the requirements of Code Section 57-5-340.

File 7.327 - Road S-256 - Beaufort County

SURPLUS RIGHT OF WAY PROPERTY - LAND

In 1953, under File 43.309, the Department added Road S-34 in the City of Sumter to the State Highway System. Under File 43.376, Road S-644 was added to the System on June 16, 1960. In 1976, under File 43.485, sections of these roads were included in the construction of improvements for U. S. Routes 15 & 521 Connection.

At the request of an adjoining owner an investigation was made and it was determined that a portion of the extra-wide right of way along U.S. Routes 15 & 521 Connection (Guignard Drive) was no longer needed and could be relinquished. Therefore, a gratis quitclaim deed conveying an approximate 1.03 acre parcel of land to Sumter Area Technical College was executed on July 21, 1992.
