**Associated Press:** Advocates ask SC legislators to expand Medicaid

Gov. Nikki Haley on Thursday touted her Medicaid agency's plan to fully reimburse rural hospitals for treating people without health insurance, as a way to stabilize rural hospitals that struggle to stay open. Haley and director Tony Keck said the policy focuses support on hot spots of poor health. "For too long, the money hasn't followed the problem," said Keck, director of the state Department of Health and Human Services.

**Note:** Dr. John Hicks, a cardiologist at Clarendon Memorial, took issue with the notion that Haley was throwing a bone to rural hospitals that are advocating for the Medicaid expansion. "It's not throwing a bone. It's throwing a lifeline," he said.

Two days after being accused by Democrats of "declaring war" on rural South Carolina, Gov. Nikki Haley rolled out more details on an initiative to provide additional funding to rural hospitals. "I have always said I'm a rural town girl," said Haley, who grew up in Bamberg. "And what you are seeing is me become a rural town governor." In her State of the State address last month, Haley first announced that the state would fully reimburse rural hospitals for care provided to people who cannot pay for it.

**Note:** Troy Gamble, chief medical officer for Williamsburg Regional Hospital, said Thursday that the facility came within two weeks of closing a few months ago. The Haley administration's new program will help keep the hospital open, he said.

Gov. Nikki Haley, who wants the state to reject expanding Medicaid, called a news conference Wednesday to draw attention to her plan for the state to pay 19 rural hospitals more for caring for uninsured patients. As the Republican governor's news conference wrapped up in the State House lobby, state Rep. James Smith, D-Richland, offered the Democratic response from a second podium that had been rolled up nearby, just before Haley began. While most political observers expect the Legislature will side with Haley on Medicaid expansion, the dueling news conferences showed that passion runs high on the subject.

**Note:** The program advocated by Haley will pump about \$20 million a year in what is called Disproportionate Share Hospital payments to facilities in rural areas. Those payments help reimburse hospitals for service given to uninsured patients. "If we can bring up health care in rural areas, we can bring up health care for all of South Carolina," Haley said.

Checking state computer logs could have spotted hackers before they stole financial data from the S.C. Department of Revenue belonging to 6.4 million consumers and businesses, two former agency employees said Thursday. The logs should have shown unusual activity as hackers searched department servers and stole data over three weeks in August and September, said the agency's former chief information officer, Mike Garon, and former computer security administrator, Scott Shealy.

Michael Garon, the agency's former chief information officer who was asked to leave the agency before the hacking was discovered, told lawmakers that he is baffled why the hacker's file transfer wasn't detected by staffers who should have been monitoring such logs.

For the first time in history, there will be two African Americans serving simultaneously in the U.S. Senate. William “Mo” Cowan, D-Mass., was sworn in Thursday by Vice President Biden to temporarily take the place of John Kerry. He joins Sen. Tim Scott, R-S.C., who also was appointed to his post. Cowan, a former chief of staff to Massachusetts Gov. Deval Patrick, will serve for about four months. He was escorted into the Senate by Secretary of State Kerry and Sen. Elizabeth Warren, D-Mass., for a brief ceremony.
