States Successful at Reducing Unintended Pregnancies

Two years ago, Colorado reported success in dramatically reducing the state's teen birth and abortion rates by 48 percent from 2009 to 2014 through a privately funded initiative that provided long-acting reversible contraception, known as LARCs. In early April, Colorado legislators approved \$2.5 million in state funding to provide LARCs to low-income women. Colorado is also among 13 states that have developed policies to remove barriers to the utilization of LARC methods for Medicaid-eligible women.

New Treasury Rules Could Affect Federal and State Tax Revenue

States may reap some revenue rewards following the rollout of new rules by the U.S. Treasury Department related to corporate income taxes. On April 4, 2016, the Treasury Department announced new regulations that are intended to make it more difficult for companies to pursue corporate inversions—the practice used by companies to reincorporate overseas in order to reduce their tax burden on income earned abroad—and to reduce subsequent profits for tax purposes—through a tactic called earnings stripping.

State Regulation of Rideshare Companies

Rideshare services such as Uber and Lyft have produced a whirlwind of state government activity since 2013 with more
