Year-End Report on the Academic Common Market

The Academic Common Market provides expanded opportunities for graduate study for residents of the participating member states of the Southern Regional Education Board (SREB). The program permits residents of any of these states who are enrolled in any specific graduate program offered to the Market by one of the other states to pay only the in-state tuition and fees at the receiving institution.

This interstate program was begun in March, 1974. Although previous summary reports have been compiled on a fiscal-year basis, the SREB staff has this year compiled "year-end" data as of March 31. Attached for your information are summary tables, prepared by SREB staff, in which are shown the cumulative numbers of students certified for participation in the Market program from March 1, 1974, through March 31, 1978 (49 months) and, separately, from July 1, 1977, through March 31, 1978 (9 months). Inspection of the first table indicates, for example, that 31 South Carolina residents have been certified for enrollment in other states; and that during the same time 47 students from other states have been certified to enroll in eligible programs in South Carolina.

Condensed from detailed figures supplied by SREB staff, the following Table shows specific programs in which South Carolina residents have been certified:
