I just heard from DPS and am now playing phone tag, but according to them, they deposited a check for \$86.82 from the LG for the 2nd quarter. SLED deposited a check from the LG for \$85.76 (should have been for \$85.75 -- think check was mistakingly written for one cent more) for the same quarter. The breakdown should have been...

SLED - \$85.75  
DPS - \$1.07  
Total - \$86.82

I still need to confirm with DPS, but they may have incorrectly billed the LG for the total amount (\$86.82) instead of \$1.07, their portion of the total bill. If that is the case, DPS owes the LG a refund of \$85.75. As soon as I hear, I will let you know.
