## THE DECLARATION OF INDEPENDENCE

When in the course of human events it becomes necessary for one people to dissolve the political bands which have connected them with another, and to assume among the powers of the earth, the separate and equal station to which the laws of nature and of nature's God entitle them, a decent respect to the opinions of mankind requires that they should declare that cause

which impel them to the separation. We hold these truths to be self-evident that all men are created equal that they are endowed by their creator with certain unalienable rights that among these are life, liberty, and the pursuit of happiness, that to secure these rights, governments are instituted among men deriving their just power from the consent of the governed.

That whenever any form of government becomes destructive of these ends, it is the right of the people to alter or to abolish it, and to institute new government, laying its foundation on such principles and organizing its powers in such form, as to them shall seem most likely to effect their safety and happiness.

Compensation to members of Congress, officers and others in matters affecting the Government. Who ever, otherwise than as provided by law for the proper discharge of official duties Directly or Indirectly receives or agrees to receive, or asks, demands, solicits, or seeks any compensation for any services rendered or to be rendered either by himself or another.

At a time when he or she is a member of Congress, members of Congress elect President Commissioner, or Resident Commissioner Elect or.

At a time when he or she is an officer or employee of the United States in ~~the~~ the Executive Legislative or Judicial Branch of the Government or in any Agency of the United States including the District of Columbia.

In Relation to any Proceeding, Application, Request for a Ruling or other Determination, Contract, Claim, Controversy, or Dispute, Accusation, Arrest, or other particular matter in which the United States is a party or has a direct and substantial interest, before any Department Agency Court martial officer or any civil military or Naval Commission or
