Within the past six months my son, Louie D. Fields, attempted to get help by applying for Medicaid and he was denied.

I am asking you to please review his case again as I feel he needs to see a doctor. He frequently has stomach pains, enough that he has to go to bed. His stomach is swollen all the time.

I have allowed him to live with me for the past two years. He has not been able to get a job and I doubt that he would be able to keep a job because of the pain. I am not physically able to work so therefore I am not able to pay for his doctor or his medication. I feel he needs to urgently see a doctor as he is always complaining of a stomach ache; and with his stomach swollen something is not right.

I do not have the money to help him as I have recently had to replace a Depuy hip that has been recalled. I am in constant pain and don't have money to help him. Please see if there is anything you can do for us.

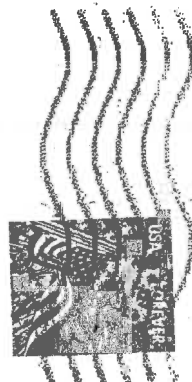
