HISTORY OF COMMUNICATION: Gov. Haley spoke with Casey Crawford in August 2014 and December 2014. Also, the Governor attended the groundbreaking in March 2015.

COMPANY OVERVIEW:

- Movement Mortgage was created in 2008.
- Casey Crawford is the co-founder and CEO of Movement Mortgage and is located in Charlotte, NC.
- In 2008, Crawford and Toby Harris established Movement Mortgage (formerly New American Mortgage).
- From 2002-2003, Casey was a member of the Super Bowl XXXVII Champion Tampa Bay Buccaneers. He played tight end for the Carolina Panthers in 2000 and 2001 and was also drafted by the Atlanta Braves in 1995. Following his NFL career, Casey entered the real estate market as an agent and investor.
- Casey attended the University of Virginia where he earned a B.A. in Sociology and achieved All-ACC academic honors.
- He has a passion for philanthropy and is an active member of his church.
- Over the next ten years, Crawford and Harris plan to transfer 100% of Movement Mortgage's shares to its non-profit foundation, Movement Foundation (after taking care of customers and employees). Crawford intends for all dividends to be paid be used to invest in community centers and charter schools. (Source: Charlotte Business Journal, Interview with Casey Crawford, May 1, 2015)
- Crawford's philanthropic philosophy is shaped by a deep personal faith, the example of a grandfather, a near-disaster after the NFL and a desire to apply a personal moral standard to his business.

DESCRIPTION OF BUSINESS

- Movement Mortgage is a mortgage bank providing mortgage loans in the United States. The company offers fixed rate mortgage loans, including Federal Housing Administration loans, Veteran's Affairs loans, and state mortgage programs for homebuyers. The company also provides refinance and reverse mortgage loans.
- The company has more than 350 locations in 40 states employing more than 3000 people. In 2015, Movement originated more than \$7.8 billion in residential mortgages. (Source: Movement Mortgage)
- Inc. Magazine recognized Movement Mortgage as the fastest-growing mortgage bank in the country.

COMMUNITY INVOLVEMENT

- The Movement Foundation, the non-profit arm of the company has reinvested more than \$16 million in communities to date. (Source: Movement Mortgage)
- Movement Foundation also acts as a source of support to those employed at Movement Mortgage and its affiliated companies - Love Works Fund. - Movement Mortgage announced plans to move its national headquarters from Virginia to northern Lancaster County creating over 600 jobs in January 2015. The company will invest \$22 million in building the new, 104,000-square-foot headquarters in Indian Land, SC.
