RE: Notification

Greetings Ms. Haley:

As the CEO of the corporate government called STATE OF SOUTH CAROLINA, this letter has been submitted to your office to provide notice to you and your successor of a simple matter that has arise which may present problems in the future worse than those you fear.

In accordance with SC Constitution Art. I, § 11 and § 17-19-10, a person must be convicted of an offense on an indictment returned by a legal grand jury or a valid waiver thereof. Here, the S.C. Court Administration has issued the court term calendar for Greenville County which show the documents that I'm being held on purporting to be indictments were not returned in the Court of General Sessions as indicated on each document. Thus, we have a legitimate case of the State through the County Solicitor's Office kidnapping its citizens for profit because there are thousands and thousands of individuals being held on such documents as these. I presented this matter to the Court of General sessions of Greenville County on February 12, 2000, but no relief has been granted. Due to the ramifications of such issue if an order from a Court was publish, in the interest of [my own physical freedom] I filed a Motion for a Bond until this matter has been resolve with the proposition of negotiating the Five-Hundred Million Dollar Agreement between myself and Solicitor Walt Wilkins

which must be paid within twenty-four (24) hours upon my release from physical confinement, but still no relief has been granted. Moreover, these documents has been presented to the Honorable Letitia H. Verdin in regards to a civil action that was filed against employees of SC Department of Corrections for the violation of my personal rights and no relief was granted. Thus, it seems that Judge Verdin has failed to understand that an issue such as this destroys the core of this state because the Solicitor's Offices of this state are publishing these fraudulent documents and the courts are circumvent the validity of these documents through manipulative case law, so an investigation will cause a governmental shut-down. Therefore, pursuant to the conduct of Judge Verdin and Solicitor Walt Wilkins I've been provided the impression that the only way I'm going to obtain relief, is by presenting it to the public through the media. Should your office take an interest in this matter, please provide the status of your position within thirty (30) days exclusive of the date of this letter. However, should your office decide that it does not have an interest in this matter, then I hope the end justifies the means on your behalf. Furthermore, should you like to review the terms of the financial agreement the Bond Motion was filed on July 5, 2013, in the Greenville County Court of General Sessions under Case Number 359487, 88, 89 and 90, which entells the terms of the agreement. I do hope we as intelligent beings come to an understanding in regards to the matter at hand, but if not let the chips fall where they may.
