- When you see all of the new hotel properties, new restaurants and shops, and new attractions that have come to fruition over the past 12 years and it's easy to see why the SEC would jump at the chance to come back to Greenville – a destination that offers an unrivaled array of quality visitor experiences for its athletes and fans.
- Landing this event is certainly a testament to our state's appeal as a travel destination and also to the hard work and forward thinking of the people here in Greenville who allow this fantastic city's tourism industry thrive.
- It also serves a significant potential catalyst for further sports tourism growth by generating greater exposure for South Carolina and elevating our reputation as a premier sports event destination.
- I believe landing this event is a major milestone for tourism in South Carolina, the first of many collegiate sporting events that will see the value and benefit of selecting our state as their next host destination...
